CONDITIONAL WATER LICENCE

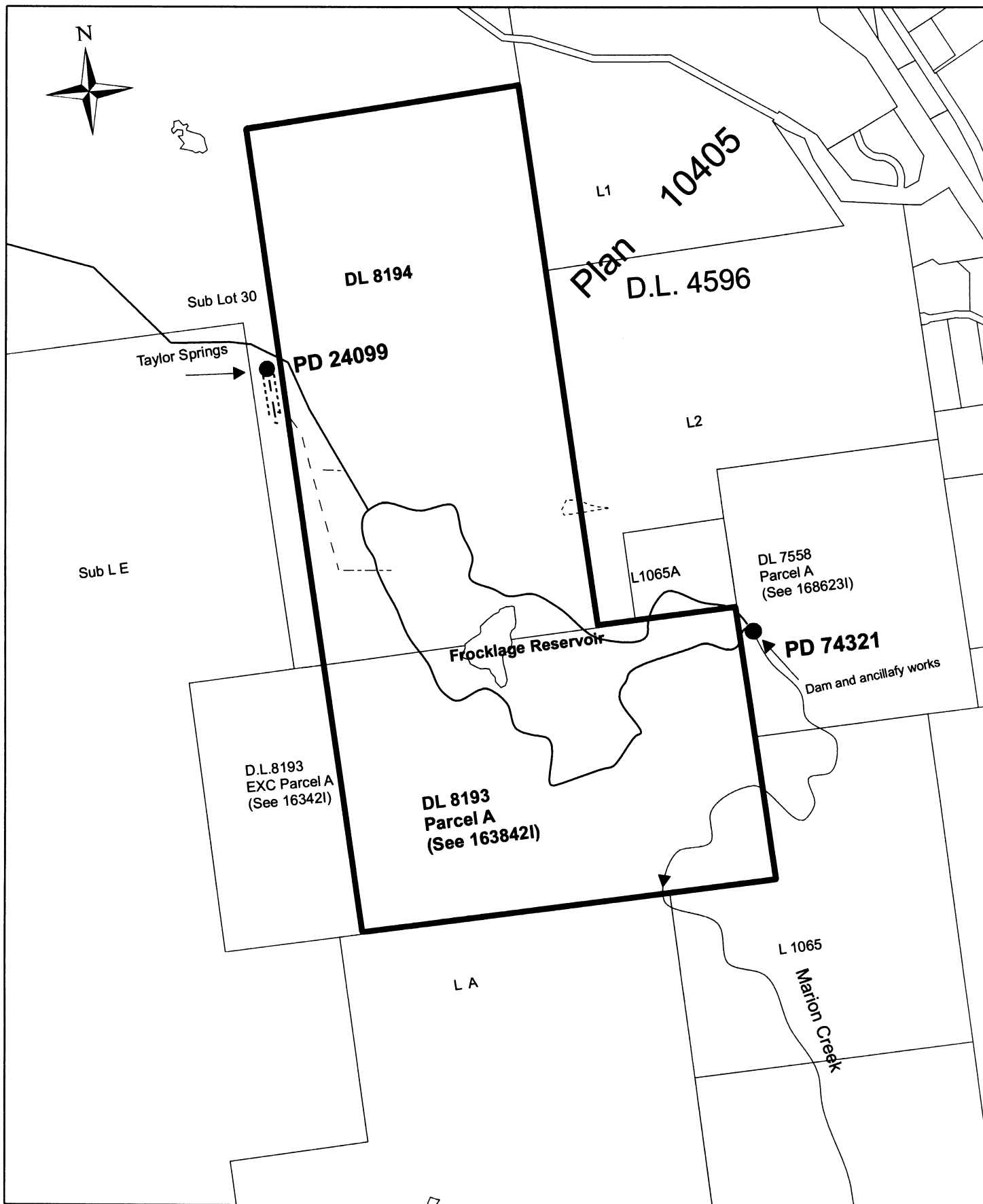
The owner of the land to which this licence is appurtenant is hereby authorized to divert and store water as follows:

- a) The stream on which the rights are granted is Taylor Springs and storage is in Frocklage Reservoir.
- b) The point of diversion and point of storage are located as shown on the attached plan.
- c) The date from which this licence shall have precedence is October 24, 1996.
- d) The purpose for which this licence is issued is conservation (storage).
- e) The maximum quantity of water which may be diverted for conservation purpose is 111,000 cubic metres per year and the maximum quantity of water which may be stored is 370,000 cubic metres.
- f) The period of the year during which the water may be diverted into storage is October 1 to March 31 and the period which water may be stored for conservation (storage) purpose is the whole year.
- g) The land upon which the water is to be used and to which this licence is appurtenant is District Lot 8194 and Parcel A (See 163842I) of District Lot 8193, Kootenay District.
- h) The authorized works are diversion structure, ditch, pipe, dam, ancillary works and reservoir which shall be located approximately as shown on the attached plan.
- i) The construction of the said works has been completed and the water is being used. The licensee shall continue to make regular beneficial use of the water in a manner authorized herein.
- j) This licence is issued pursuant to the provisions of the Water Act to ensure compliance with that statute, which makes it an offence to divert or use water from a stream in British Columbia without proper authorization. It is the responsibility of the licensee to ensure that all activities conducted under this authorization are carried out with regard to the rights of third parties, and comply with other applicable legislation that may be in force.

- k) The dam authorized under clause (h) is subject to the Dam Safety Regulations and shall be designed, constructed and maintained to the satisfaction of a Dam Safety Officer under the Water Act and in accordance with the Canadian Dam Association Guidelines.
- l) The maximum rate of diversion from Taylor Springs shall not exceed 0.0093 cubic metres per second.
- m) This Licence is issued in substitution of Conditional Water Licence 111687.
