CONDITIONAL WATER LICENCE

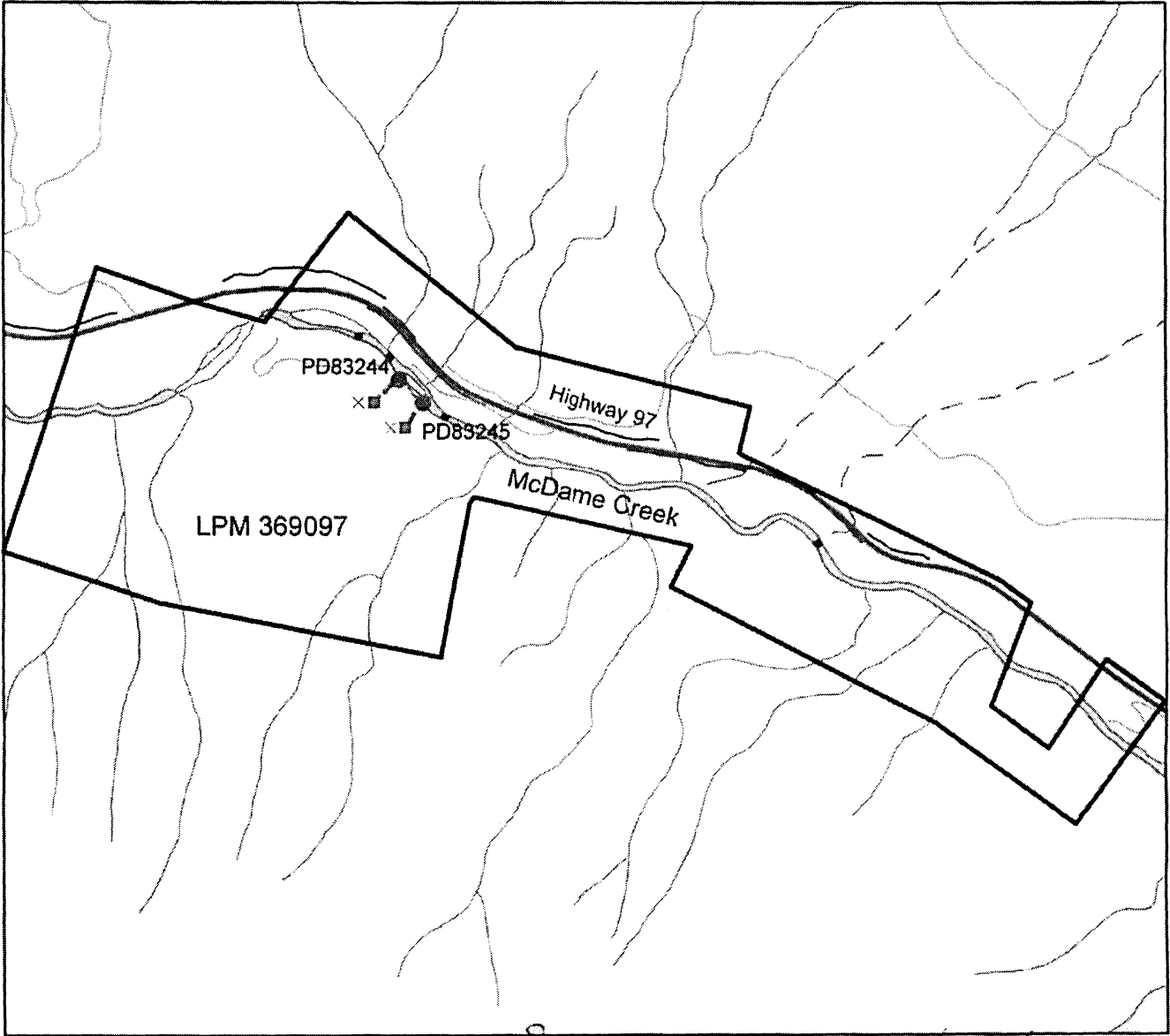
The holder(s) of Placer Tenure 369097 to which this licence is appurtenant is/are hereby authorized to divert and use water as follows:

- a) The stream on which the rights are granted is McDame Creek.
- b) The points of diversion are located as shown on the attached plan. Only one point of diversion may be used at any one time.
- c) The date from which this licence shall have precedence is January 8, 2013.
- d) The purpose for which this licence is issued is placer mining.
- e) The maximum quantity of water which may be diverted for placer mining is 0.014 cubic metres per year.
- f) The period of the year during which the water may be used is March 1 to November 30.
- g) The land upon which the water is to be used and to which this licence is appurtenant is Placer Tenure 369097.
- h) The authorized works are diversion structure, screened intake, pump, pipe, wash plant, and settling ponds, which shall be located approximately as shown on the attached plan.
- i) The construction of the said works has been completed and the water is being used. The licensee shall continue to make regular beneficial use of the water in a manner authorized herein.
- j) The works authorized in clause (h) hereof shall be constructed and used in accordance with the approved Notice of Work.
- k) All waste water generated from the washing of gravels must be directed through a settling pond system to remove suspended solids before being returned to the stream.
- l) All mined or otherwise disturbed ground surfaces including cut banks and fill slopes shall be stabilized to prevent tailings, forest cover, top soil and debris from entering into water courses.

- m) The riparian (vegetation) zone adjacent to McDame Creek shall be protected from all activities associated with placer mining. Placer operations within those aforementioned tenures shall be prohibited within 10 metres of the high water mark measured from both sides of the stream, including the bed and banks of the stream.
- n) The diversion of water authorized under this licence may be restricted or prohibited at any time by an order of an Engineer or Regional Water Manager under the Water Act, in order to maintain a minimum flow in the stream.
- o) The licence will be valid until December 31, 2015. Prior to the termination date, you may apply to the Regional Water Manager in accordance with the provisions of the Water Act to extend the term of this licence.
- p) This Licence is issued in substitution of Conditional Water Licence 125465.
