## *Water Act*

### FINAL WATER LICENCE

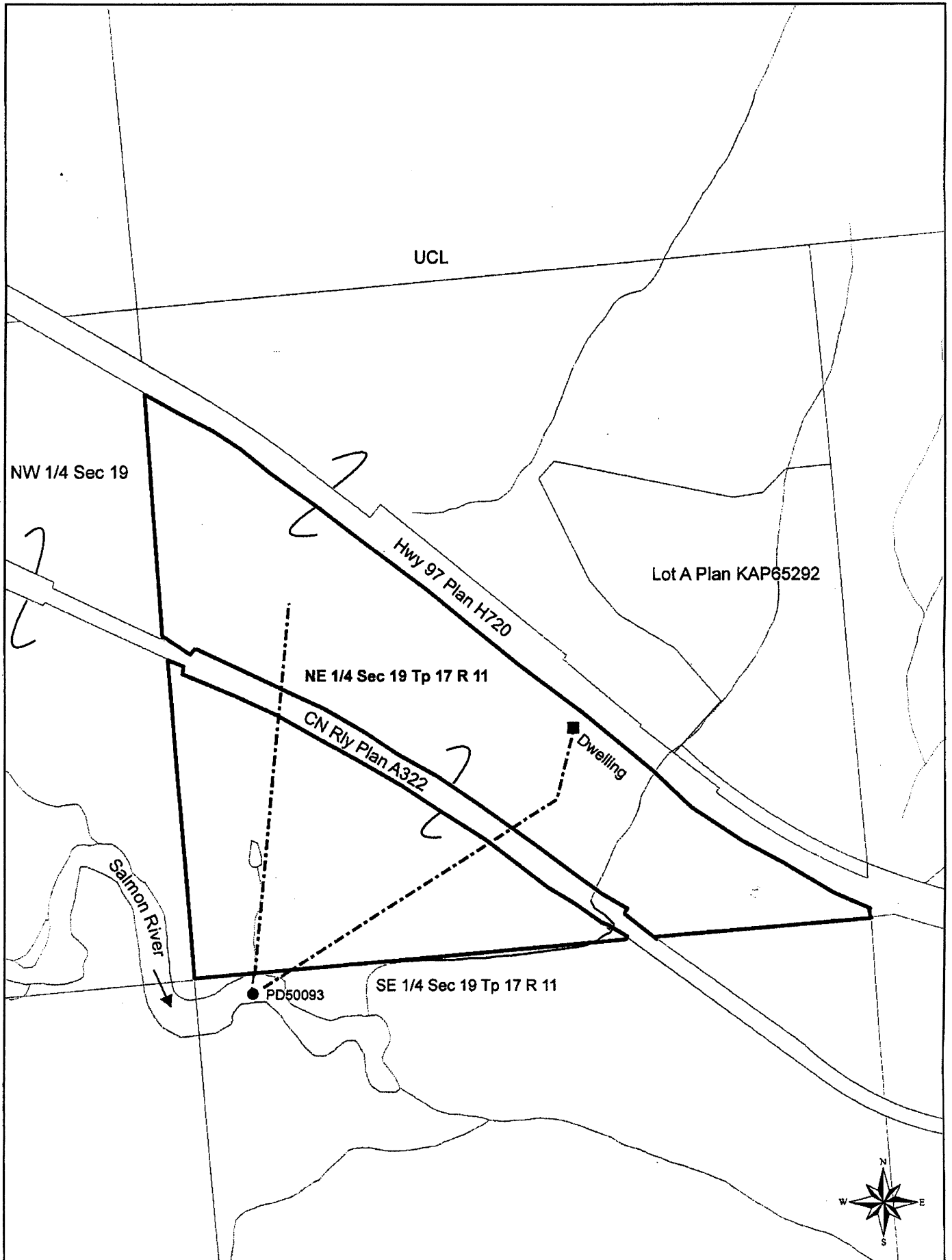
The owner(s) of the land to which this licence is appurtenant are hereby authorized to divert and use water as follows:

- a) The stream on which the rights are granted is Salmon River.
- b) The point of diversion is located as shown on the attached plan.
- c) The date from which this licence shall have precedence is 8th July, 1907.
- d) The purposes] for which this licence is issued are domestic and irrigation.
- e) The maximum quantity of water which may be diverted for domestic is 2.27 cubic metres (500 gallons) per day and the maximum quantity which may be used for irrigation is 80,800 cubic metres (65.5 acre feet) per annum
- f) The period of the year during which the water may be used for domestic is the whole year and for irrigation is April 1 to September 30.
- g) The land upon which the water is to be used and to which this licence is appurtenant is North East 1/4 Section 19 Township 17 Range 11 West of the 6th Meridian Kamloops Division Yale District except Plans A322 and KAP65292 of which 13.2 hectares (32.7 acres) may be irrigated.
- h) The authorized works are diversion structure, pump, pipe and sprinklers which shall be located approximately as shown on the attached plan.
- i) The construction of the said works has been completed and the water is being used. The licensee shall continue to make regular beneficial use of the water in a manner authorized herein.

- j) This licence is issued under the Water Act (the Act). The exercise of rights under the licence is subject to the Act and its regulations, the terms and conditions of the licence, orders under the Act and the rights of licensees whose rights have precedence on the stream. The licensee must comply with all such requirements, as well as the provisions of all other applicable enactments. In exercising rights under the licence, the licensee must exercise reasonable care to avoid damaging land, works, trees or other property, and must make full compensation to the owners for damage or loss resulting from construction, maintenance, use, operation or failure of the works.
- k) This licence authorizes the use of water for domestic purpose in one (1) dwelling located approximately as shown on the attached plan.
- l) This licence is issued in substitution of Final Water Licence 40855.

**ORDER**

In the matter of Conditional Water Licence No. C130584 which authorizes the diversion and use of water from Winchie Creek, Bearberry Brook and Silverweed Creek for Power (general) purpose and is appurtenant to the Winchie Creek Hydro Power Project, tenured under the *Land Act*, held under Lands File No. 1413113.

In response to a formal request for an extension of time to complete the project, and being satisfied that no person's rights will be injuriously affected, I hereby amend the licence to read as follows:

- (i) The construction of the said works shall be completed and the water shall be beneficially used prior to December 31, 2018. Thereafter, the licensee shall continue to make regular beneficial use of the water in the manner authorized herein.
