

Province of British Columbia Water Act

CONDITIONAL WATER LICENCE

The Federal Government of Canada, as represented by the Department of Fisheries and Oceans Canada is hereby authorized to store, divert and use water as follows:

- a) The stream on which the rights are granted is Qualicum River and storage is in the reservoir on Horne Lake.
- b) The point of diversion and re-diversion are located as shown on the attached plan.
- c) The date from which this licence shall have precedence is February 17, 1960.
- d) The purposes for which this licence is issued are storage and conservation (artificial spawning channels).
- e) The maximum quantity of water which may be diverted for conservation purpose is 7.08 cubic metres per second and the maximum quantity of water which may be held in storage is 77,710,000 cubic metres per year.
- f) The period of the year during which the water may be used is the whole year.
- g) The land upon which the water is to be used and to which this licence is appurtenant is the conservation project of the licensee within Those parts of District Lot 254, Alberni District, shown outlined in red on Plan 1753R, except for parts in Plans VIP78396 and VIP78397.
- h) The authorized works are dam, spillway with an elevation of 120.76 metres (Geodetic Survey of Canada), deep intakes, control gates, tunnel, penstock, diversion weir, artificial spawning channels and alterations to the channel of Qualicum River which shall be located approximately as shown on the attached plan.
- i) The construction of the said works has been completed and the water is being used. The licensee shall continue to make regular beneficial use of the water in a manner authorized herein.
- j) The dam authorized under clause (h) is subject to the Dam Safety Regulations and shall be designed, constructed and maintained to the satisfaction of a Dam Safety Officer under the *Water Act* and in accordance with the Canadian Dam Association Guidelines.
- k) The level of Horne Lake shall be maintained so that the minimum elevation is no less than 111 metres (Geodetic Survey of Canada).


- 1) The licensee herein shall provide up to a maximum of 0.28 cubic metres per second of water to be released from either Horne Lake or Qualicum River channel or combination of Horne Lake and the Qualicum River channel for the diversion and use of water under a licence or licences that may be issued by the Comptroller of Water Rights.
- m) This licence is issued in substitution of Conditional Water Licences C026113 and C026114.
