

## Province of British Columbia Water Act

## CONDITIONAL WATER LICENCE

The owner of the land to which this licence is appurtenant is hereby authorized to divert and use water as follows:

- a) The stream on which the rights are granted is White Creek and the re-diversion is from White Lake.
- b) The points of diversion and re-diversion are located as shown on the attached plan.
- c) The date from which this licence shall have precedence is June 1, 1993.
- d) The purpose for which this licence is issued is domestic and industrial (stock watering).
- e) The maximum quantity of water which may be diverted for domestic purpose is 2.27 m<sup>3</sup> per day and the maximum quantity which may be used for Industrial purpose (stock watering) is 0.91 m<sup>3</sup> per day.
- f) The period of the year during which the water may be used for domestic purpose is the whole year and for industrial purpose (stock watering) is the whole year.
- g) The land upon which the water is to be used and to which this licence is appurtenant is Lot 1, Section 15, Township 22, Range10, West of the 6th Meridian, Kamloops Division Yale District, Plan KAP75554.
- h) The authorized works are screened intake, pipe, pump, and trough which shall be located approximately as shown on the attached plan.
- i) The construction of the said works has been completed and the water is being used. The licensee shall continue to make regular beneficial use of the water in a manner authorized herein.

- j) This licence is issued under the Water Act (the Act). The exercise of rights under the licence is subject to the Act and its regulations, the terms and conditions of the licence, orders under the Act and the rights of licensees whose rights have precedence on the stream. The licensee must comply with all such requirements, as well as the provisions of all other applicable enactments. In exercising rights under the licence, the licensee must exercise reasonable care to avoid damaging land, works, trees or other property, and must make full compensation to the owners for damage or loss resulting from construction, maintenance, use, operation or failure of the works.
- k) This licence authorizes the use of water for domestic purpose in one dwelling located approximately as shown on the attached plan.
- The industrial stock watering purpose authorized by this licence is for use outside the
  wetted perimeter of the source in a trough located approximately as shown on the attached
  plan.
- m) Any water diverted and used pursuant to this licence, must be taken from storage provided in the reservoir authorized under Water Licence C105691 or any licence issued in substitution thereof.
- n) The rights granted herein are exercisable only during such times as the licensee remains a member of the White Lake/White Creek Water Users' Community, and as long as works under Water Licence C105691, or any licence issued in substitution thereof, are being maintained and operated to the satisfaction of an Engineer under the Water Act.
- o) This licence does not authorize the diversion and use of water at any time when the water level of White Lake falls below 29.718 metres (97.5 feet) as shown on Drawing Number 1012.001 without written approval from the Regional Water Manager or an Engineer under the Water Act.
- p) This Licence is issued in substitution of Water Licence C117230, in part.
