Water Act

CONDITIONAL WATER LICENCE

The owner(s) of the land to which this licence is appurtenant is/are hereby authorized to divert and store water as follows:

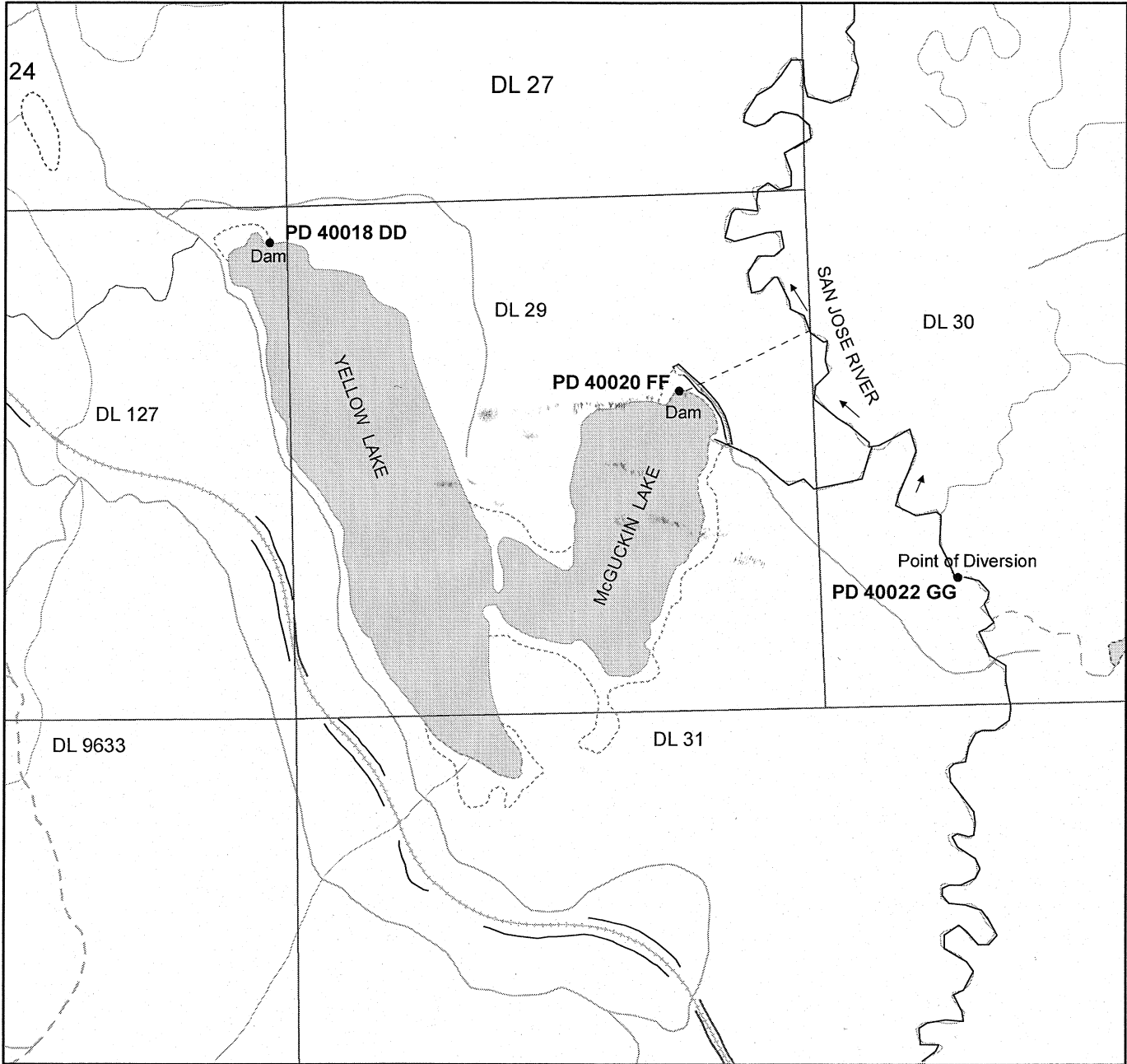
- a) The stream on which the rights are granted is the San Jose River and storage is in the following reservoirs: Yellow Lake, McGuckin Lake and Lac La Hache.
- b) The storage sites are located as shown on the attached plans.
- c) The date from which this licence shall have precedence is December 8th, 1926.
- d) The purpose for which this licence is issued is storage.
- e) The maximum quantity of water which may be diverted for storage is 1,603.5 cubic metres (1.3 acre feet) per annum in Yellow Lake, 1,603.5 cubic metres (1.3 acre feet) per annum in McGuckin Lake and 3,207.1 cubic metres (2.6 acre feet) per annum in Lac La Hache.
- f) The period of the year during which the water may be diverted into storage and stored is October 1st to June 15th.
- g) The land upon which the water is to be used and to which this licence is appurtenant is as set out in Conditional Water Licence No. 131695.
- h) The authorized works are diversion structures, ditches and dams on Yellow Lake and McGuckin Lake and a dam on Lac La Hache which shall be located approximately as shown on the attached plan. The intake to Yellow Lake and McGuckin Lake shall be screened to prevent debris and fish from entering the works.
- i) The construction of the said works has been completed and the water is being used. The licensee shall continue to make regular beneficial use of the water in a manner authorized herein.
- j) The dam authorized under clause (h) is subject to the Dam Safety Regulations and shall be designed, constructed and maintained to the satisfaction of a Dam Safety Officer under the Water Act and in accordance with the Canadian Dam Association Guidelines.

- k) This licence is issued under the Water Act (the Act). The exercise of rights under the licence is subject to the Act and its regulations, the terms and conditions of the licence, orders under the Act and the rights of licensees whose rights have precedence on the stream. The licensee must comply with all such requirements, as well as the provisions of all other applicable enactments. In exercising rights under the licence, the licensee must exercise reasonable care to avoid damaging land, works, trees or other property, and must make full compensation to the owners for damage or loss resulting from construction, maintenance, use, operation or failure of the works.

- l) This Licence is issued in substitution of Conditional Water Licence No. 069105, in part.

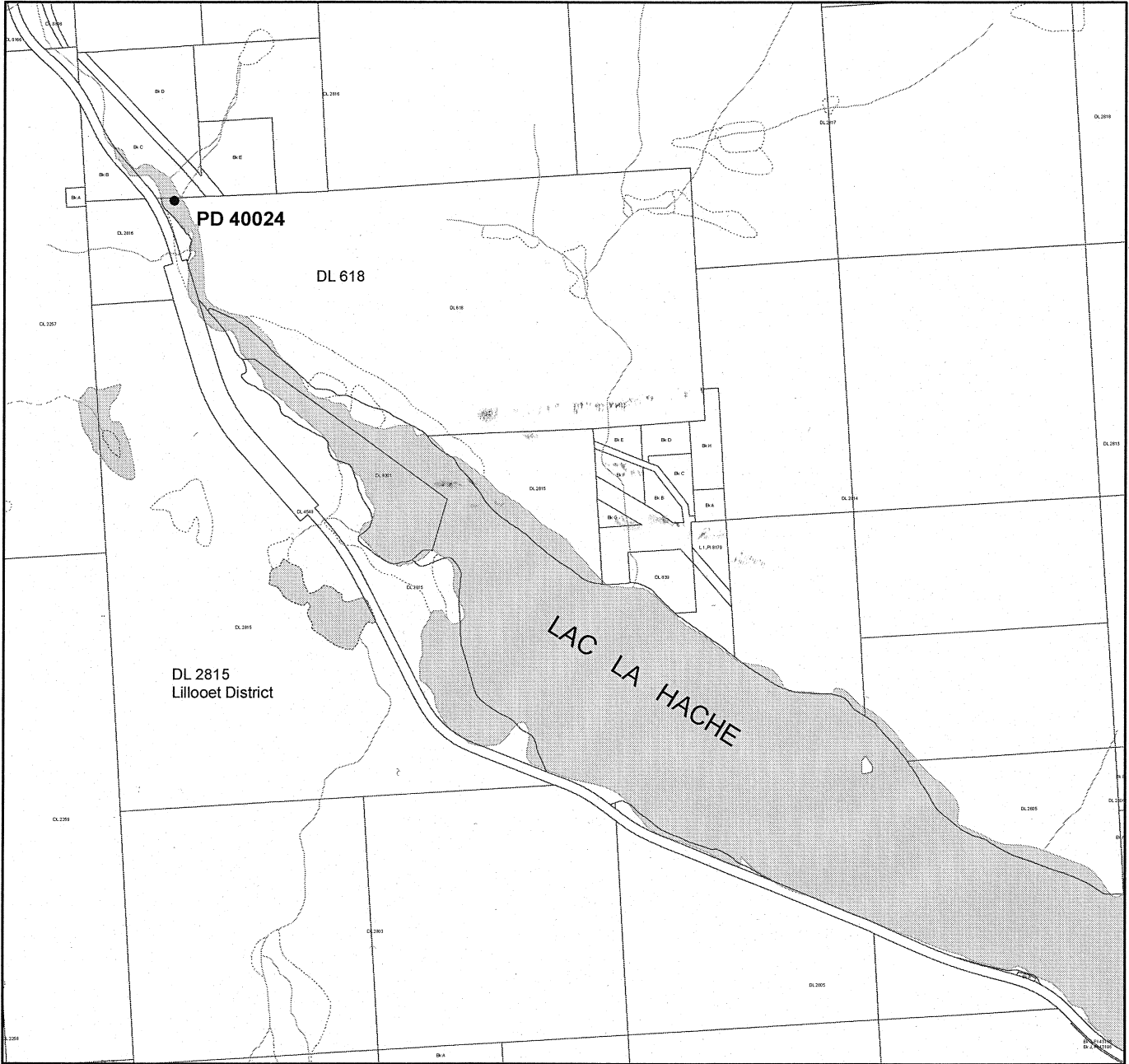
WATER DISTRICT: CARIBOO

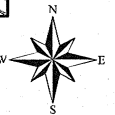
