

Province of British Columbia Water Act

CONDITIONAL WATER LICENCE

The owners of the land to which this licence is appurtenant are hereby authorized to divert and use water as follows:

- a) The stream on which the rights are granted is Puntzi Creek.
- b) The point of diversion is located as shown on the attached plan.
- c) The date from which this licence shall have precedence is 11th of August, 1953.
- d) The purpose for which this licence is issued is irrigation.
- e) The maximum quantity of water which may be diverted and used for irrigation is 98,679.2 cubic meters per annum.
- f) The period of the year during which the water may be used is 1st April to 30th September.
- g) The land upon which the water is to be used and to which this licence is appurtenant is Parcel A, District Lots 107, 288 and 1917 Range 3 Coast District Plan PGP37112 of which 16.187 hectares may be irrigated.
- h) The authorized works are screened intake, pump, pipe and sprinkler system, which shall be located approximately as shown on the attached plan. The intake shall be adequately screened to prevent debris and fish from entering the works.
- i) The construction of the said works has been completed and the water is being used. The licensee shall continue to make regular beneficial use of the water in a manner authorized herein and in accordance with the terms of Schedule 'A' of the Puntzi compact attached.
- j) This licence is issued under the Water Act (the Act). The exercise of rights under the licence is subject to the Act and its regulations, the terms and conditions of the licence, orders under the Act and the rights of licensees whose rights have precedence on the stream. The licensee must comply with all such requirements, as well as the provisions of all other applicable enactments. In exercising rights under the licence, the licensee must exercise reasonable care to avoid damaging land, works, trees or other property, and must make full compensation to the owners for damage or loss resulting from construction, maintenance, use, operation or failure of the works.



SCHEDULE 'A' - AS PART OF CONDITIONAL WATER LICENCE 107908

PUNTZI CREEK

Fish Protection Requirements - Puntzi Drainage

- i) Any structures constructed in Puntzi Creek must be certified as suitable to pass fish by the B.C. Ministry of Environment, Lands and Parks.
- ii) Removals of water by backflooding must leave the following natural flows in Puntzi Creek, measured 1 kilometre upstream from Puntzi Lake:

Time Period	<u>Dry Year</u> (instantaneo	Average Year us flow in cfs)
April 1 to April 21	1.5	2
April 22 to May 7	4	6
May 8 to July 15	1.5	2
July 16 to October 31	1	1
November 1 to February 28	1	1.5
March 1 to March 31	1	1

- iii) If natural flows in Puntzi Creek do not meet 'dry year' minimums, any holder of a backflood licence may petition the Local Monitoring Team to request designation of a Critical Period by the Water Management Office, Williams Lake. This designation shall be solely on the basis of hydrological data. When a Critical Period is designated, fisheries experts in the regional office of the Ministry of Environment, Lands and Parks, in consultation with the licensee, shall develop a flow management plan that:
 - provides for the survival of fish
 - permits a level of water use by the licensee

When natural flows again reach dry year minimum flows, the Water Management Office shall cancel the Critical Period determination.

iv) The provisions in this schedule shall be reviewed, and if appropriate, adjusted very five years by the regional Water Management and Fish and Wildlife offices, Ministry of Environment, Lands and Parks. The Ministry of Agriculture, Fisheries and Food shall participate in this review. The Regional Water Manager may grant a review at any time, if petitioned by one of the licensees or by one of the above named agencies.
