## *Water Act*

### CONDITIONAL WATER LICENCE

The owner(s) of the land to which this licence is appurtenant is hereby authorized to divert and use water as follows:

- a) The stream on which the rights are granted is Rapp Creek.
- b) The points of diversion and re-diversion are located as shown on the attached plan.
- c) The date from which this licence shall have precedence is October 9, 2012.
- d) The purposes for which this licence is issued are Domestic and Land Improvement.
- e) The maximum quantity of water which may be diverted for Domestic purpose is 4.5461 cubic metres (1000 gallons) per day and the maximum quantity which may be used for land improvement is 65 cubic metres (0.05 acre-feet) per year.
- f) The period of the year during which the water may be used for Domestic purpose is May 1 to November 30 and for the purpose of Land Improvement is the whole year.
- g) The land upon which the water is to be used and to which this licence is appurtenant is that part of the South 1/2 of District Lot 1827 Kamloops Division Yale District lying to the right of the right bank of Rapp Creek and to the West of Lemieux Creek Road.
- h) The authorized works are two berms, a bypass channel, diversion structure, pump, pipe, and standpipe which shall be located approximately as shown on the attached plan.
- i) The construction of the said works shall be completed and the water shall be beneficially used prior to December 31, 2017. Thereafter, the licensee shall continue to make regular beneficial use of the water in the manner authorized herein.
- j) This licence is issued under the Water Act (the Act). The exercise of rights under the licence is subject to the Act and its regulations, the terms and conditions of the licence, orders under the Act and the rights of licensees whose rights have precedence on the stream. The licensee must comply with all such requirements, as well as the provisions of all other applicable enactments. In exercising rights under the licence, the licensee must exercise reasonable care to avoid damaging land, works, trees or other property, and must make full compensation to the owners for damage or loss resulting from construction, maintenance,

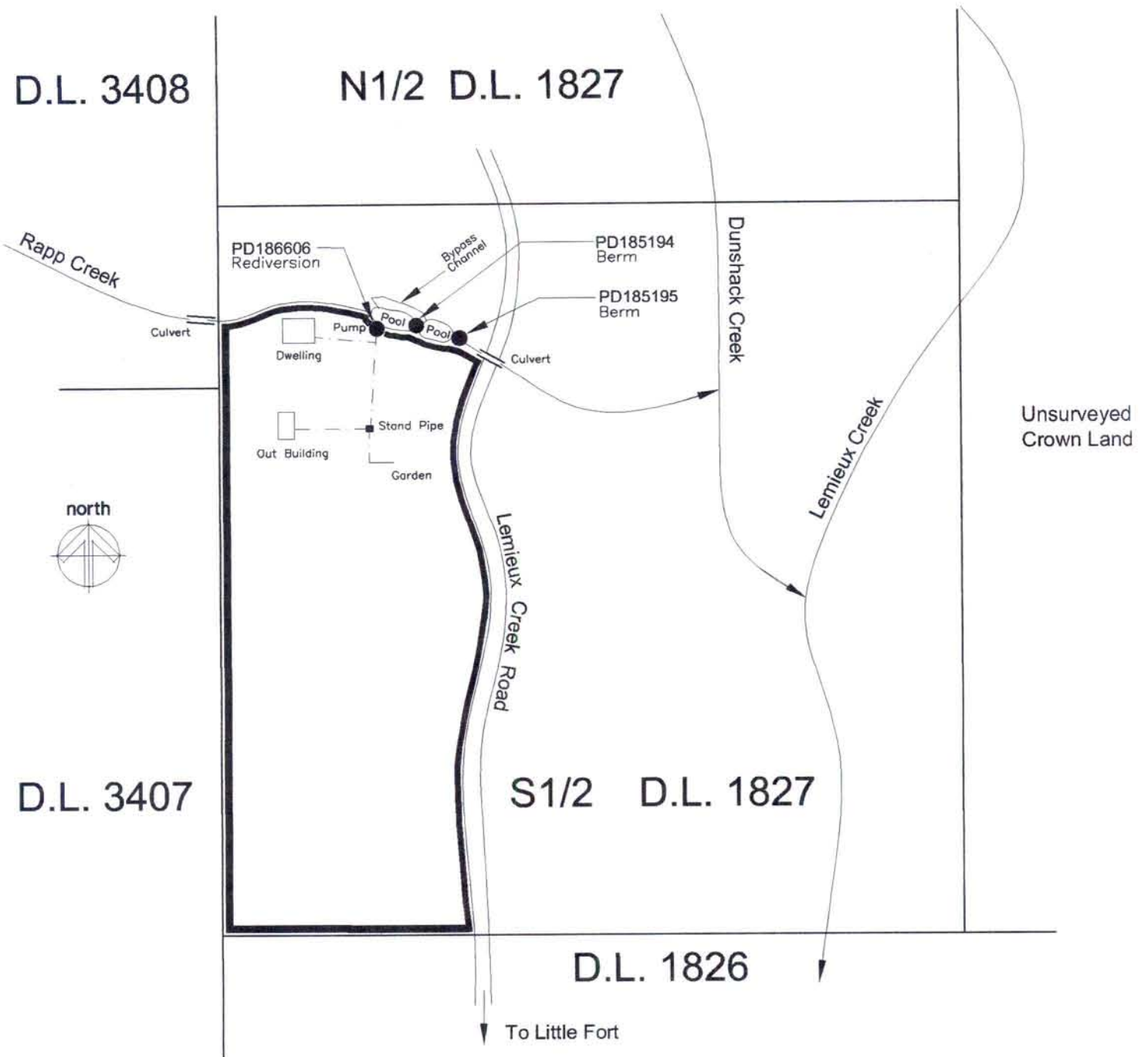
use, operation or failure of the works.

- k) This licence authorizes the use of water for domestic purpose in one dwelling and an out-building located approximately as shown on the attached plan.
