

Province of British Columbia Water Act

CONDITIONAL WATER LICENCE

The owner(s) of the land to which this licence is appurtenant is/are hereby authorized to divert, use and store water as follows:

- a) The stream on which the rights are granted is Chimney Creek and the reservoirs are on Brunson Lake and in the creek.
- b) The points of diversion are located as shown on the attached plan.
- c) The date from which this licence shall have precedence is July 18, 1928.
- d) The purposes for which this licence is issued are storage and irrigation.
- e) The maximum quantity of water which may be diverted for storage is 111,013.2 cubic metres (90 acre feet) per annum and the maximum quantity of water that may be used for irrigation is 111,013.2 cubic metres (90 acre feet) per annum.
- f) The period of the year during which the water may be diverted to fill the reservoir is October 1st to June 15th and the stored water may be used during the irrigation period from April 1st to September 30th.
- g) The land upon which the water is to be used and to which this licence is appurtenant is District Lot 300, West of Plan PGP36830 Cariboo District, of which 18.2 hectares (45 acres) may be irrigated.
- h) The authorized works are dams, diversion structure with screened intake, pump, pipe and sprinkler system which shall be located approximately as shown on the attached plan.
- i) The construction of the said works has been completed and the water is being used. The licensee shall continue to make regular beneficial use of the water in a manner authorized herein.
- j) The dam authorized under clause (h) is subject to the Dam Safety Regulations and shall be designed, constructed and maintained to the satisfaction of a Dam Safety Officer under the Water Act and in accordance with the Canadian Dam Association Guidelines.
- k) Works shall be installed to meter and record the rate of flow and quantity of water diverted


under the licence. Flow meter records shall be retained by the licensee and be available upon request for inspection by the Regional Water Manager or Assistant Regional Water Manager.

- 1) The intake shall be screened to prevent debris and fish from entering the works.
- m) This licence is issued under the Water Act (the Act). The exercise of rights under the licence is subject to the Act and its regulations, the terms and conditions of the licence, orders under the Act and the rights of licensees whose rights have precedence on the stream. The licensee must comply with all such requirements, as well as the provisions of all other applicable enactments. In exercising rights under the licence, the licensee must exercise reasonable care to avoid damaging land, works, trees or other property, and must make full compensation to the owners for damage or loss resulting from construction, maintenance, use, operation or failure of the works.
- n) This Licence is issued in substitution of Conditional Water Licence No. 118939.


