
## *Water Act*

### CONDITIONAL WATER LICENCE

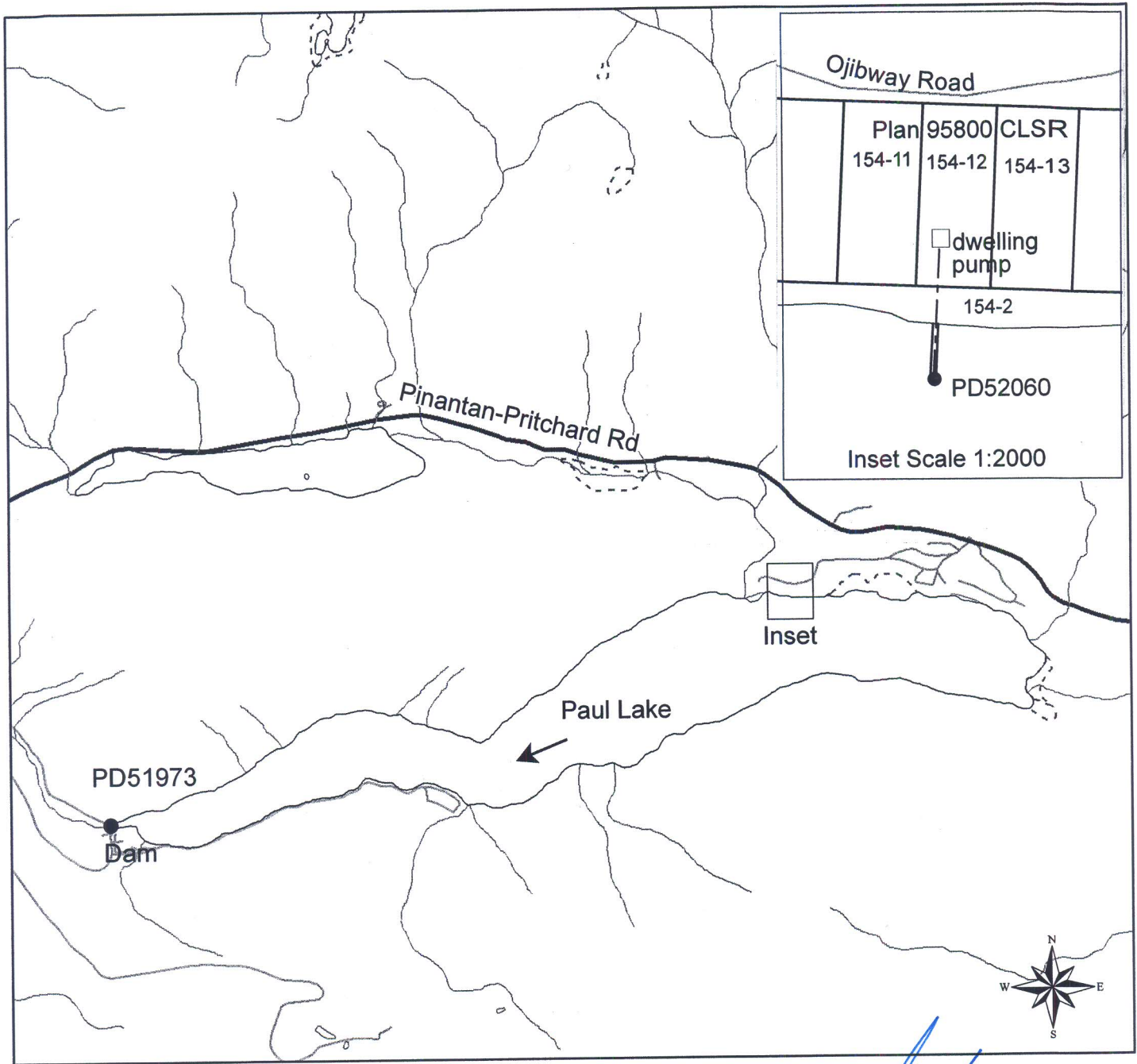
The holder of a lease to which this licence is appurtenant is/are hereby authorized to divert, use and store water as follows:

- a) The stream on which the rights are granted is Paul Lake and storage is in Paul Lake.
- b) The storage site and the point of diversion are located as shown on the attached plan.
- c) The date from which this licence shall have precedence is June 17, 1976.
- d) The purposes for which this licence is issued are domestic and storage.
- e) The maximum quantity of water which may be diverted for domestic purpose is 2.27305 cubic metres (500 imperial gallons) per day and the maximum quantity which may be diverted for storage purpose is 826.43160 cubic metres (0.67 acre foot) per annum.
- f) The period of the year during which water may be diverted into storage and used is the whole year.
- g) The land upon which the water is to be used and to which this licence is appurtenant is Lot 154-12 Kamloops Indian Reserve #1 Plan 95800 CLSR.
- h) The authorized works are diversion structure, pump, pipe and dam which shall be located approximately as shown on the attached plan.
- i) The construction of the said works has been completed and the water is being used. The licensee shall continue to make regular beneficial use of the water in a manner authorized herein.
- j) This licence is issued under the Water Act (the Act). The exercise of rights under the licence is subject to the Act and its regulations, the terms and conditions of the licence, orders under the Act and the rights of licensees whose rights have precedence on the stream. The licensee must comply with all such requirements, as well as the provisions of all other applicable enactments. In exercising rights under the licence, the licensee must exercise reasonable care to avoid damaging land, works, trees or other property, and must make full compensation to the owners for damage or loss resulting from construction, maintenance, use, operation or failure of the works.


- k) The dam authorized under clause (h) is subject to the Dam Safety Regulations and shall be designed, constructed and maintained to the satisfaction of a Dam Safety Officer under the Water Act and in accordance with the Canadian Dam Association Guidelines.
- l) This licence authorizes the use of water for domestic purpose in one dwelling located approximately as shown on the attached plan.
- m) This Licence is issued in substitution of Conditional Water Licences 48911 & 48912.
