
Water Act

CONDITIONAL WATER LICENCE

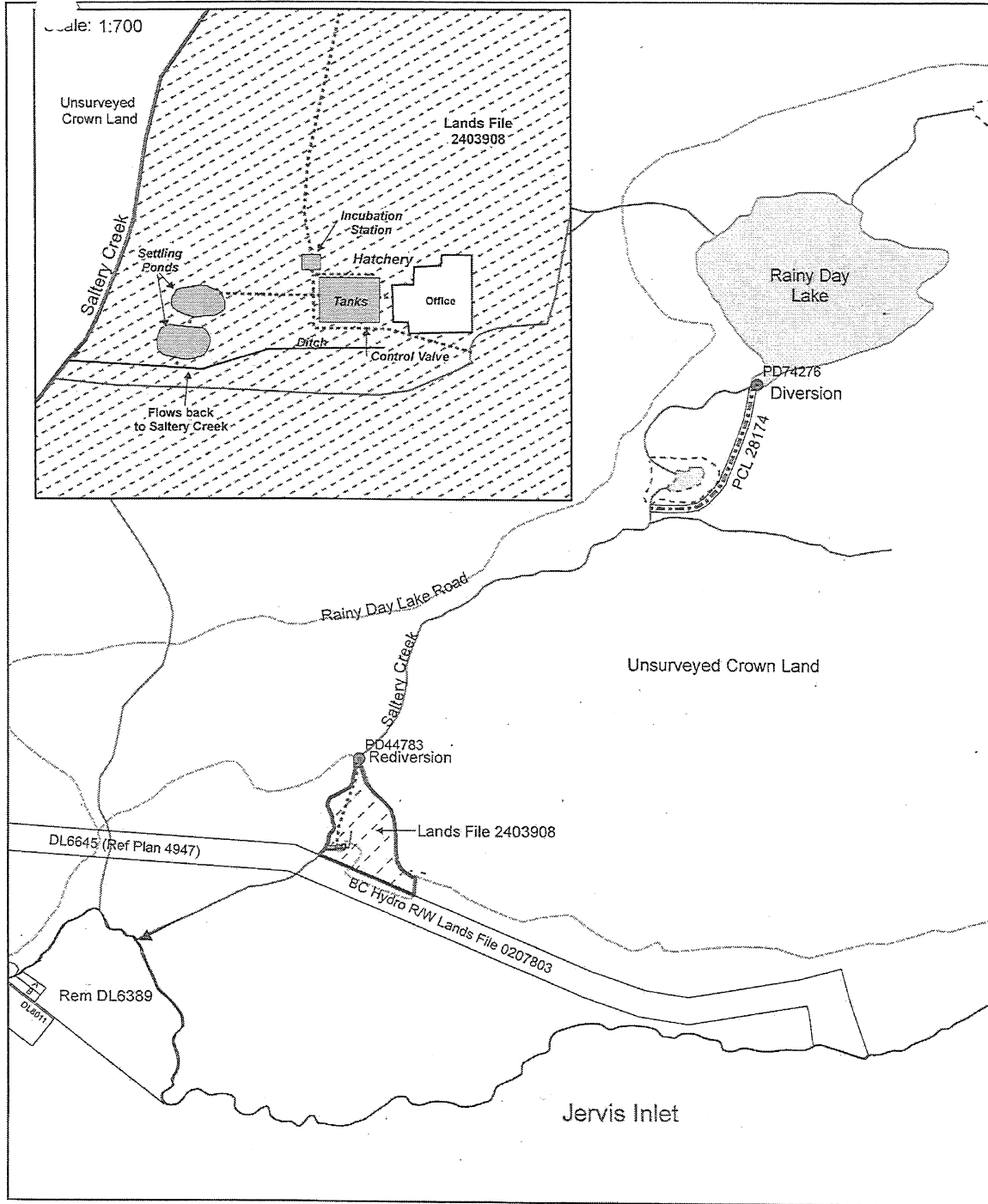
The holders of a Licence of Occupation, held under Lands File 2403908, to which this licence is appurtenant are hereby authorized to divert and use water as follows:

- a) The streams on which the rights are granted are Rainy Day Lake with a redirection on Sallery Creek.
- b) The point of diversion on Rainy Day Lake and point of redirection on Sallery Creek are located as shown on the attached plan.
- c) The date from which this licence shall have precedence is May 24, 1988.
- d) The purpose for which this licence is issued is industrial (fish hatchery).
- e) The maximum quantity of water which may be diverted for industrial (fish hatchery) purpose is 45.46 cubic meters (10,000 gallons) per day, between July 1 to January 31 and 2,273 cubic meters (500,000 gallons) per day, between February 1 to June 30.
- f) The period of the year during which the water may be used is the whole year.
- g) The land upon which the water is to be used and to which this licence is appurtenant is that parcel or tract of land in the vicinity of Sallery Bay, Group 1, New Westminster District, held under Lands File 2403908.
- h) The authorized works are screened intakes, pipes, diversion structure, hatchery, settling ponds and ditch which shall be located approximately as shown on the attached plan.
- i) The construction of the said works has been completed and the water is being used. The licensee shall continue to make regular beneficial use of the water in a manner authorized herein.
- j) The diversion of water authorized under this licence may be restricted or prohibited at any time by an Order in writing of an Engineer under the Water Act, in order to maintain a minimum flow in the stream for the preservation of fish and other aquatic life.

- k) This licence remains active pursuant to the active status of the Licence of Occupation granted under the Lands File as noted in (g) above and may be subject to cancellation if the Licence of Occupation expires.
- l) This Licence is issued in substitution of Conditional Water Licence C128604.
