

## Province of British Columbia Water Act

## CONDITIONAL WATER LICENCE

The owner of the land to which this licence is appurtenant is hereby authorized to divert and use water as follows:

- a) The stream on which the rights are granted is Klitsa Creek.
- b) The point of diversion is located as shown on the attached plan.
- c) The date from which this licence shall have precedence is November 01, 2000.
- d) The purpose for which this licence is issued is power (general).
- e) The maximum quantity of water which may be diverted for power (general) purpose is 1.0 cubic metres per second.
- f) The period of the year during which the water may be used is the whole year.
- g) The land upon which the water is to be used and to which this licence is appurtenant is The South ½ of Lot 684, Clayoquot District, containing 71.5 acres, more or less, except part in Plan VIP89292, on which the powerhouse is situated, this licence is appurtenant to the said portion.
- h) The authorized works are, intake, penstock, powerhouse, tailrace, and transmission line, which shall be located approximately as shown on the attached plan.
- i) The construction of the said works shall be completed and the water shall be beneficially used prior to December 31, 2018. Thereafter, the licensee shall continue to make regular beneficial use of the water in the manner authorized herein.
- j) The construction and or reconstruction of the works authorized in clause (h) shall not commence until plans prepared by a professional engineer registered in British Columbia have been submitted to and written leave to commence construction granted by an engineer under the *Water Act*.
- k) Before commencing operation of the works authorized under clause (h), the licensee must:
  - 1. Submit a report for acceptance by the Regional Water Manager on the parameters and procedures for the operation of the works;
  - 2. Submit and implement a plan to the satisfaction of the Regional Water Manager for the measurement of in-stream flows and of the flow of water diverted from the stream under this licence; and
  - 3. Obtain Leave to Commence the diversion and use of water authorized in this licence in writing from the Regional Water Manager.

- 1) The licensee shall retain flow meter records for inspection upon request by an Engineer under the *Water Act*.
- m) As-Built, record drawings or an equivalent must be submitted to an Engineer under the *Water Act* within one year of commissioning.
- n) The licensee shall adjust the diversion, rate of diversion, and use of water as may be ordered by an Engineer under the *Water Act* from time to time, for the preservation of fish and fish habitat.
- o) The term of this licence is forty (40) years from the date of issuance of Conditional Water Licence C115710; October 17, 2003.
- p) This licence is issued in substitution of Conditional Water Licence C130883.
