CONDITIONAL WATER LICENCE

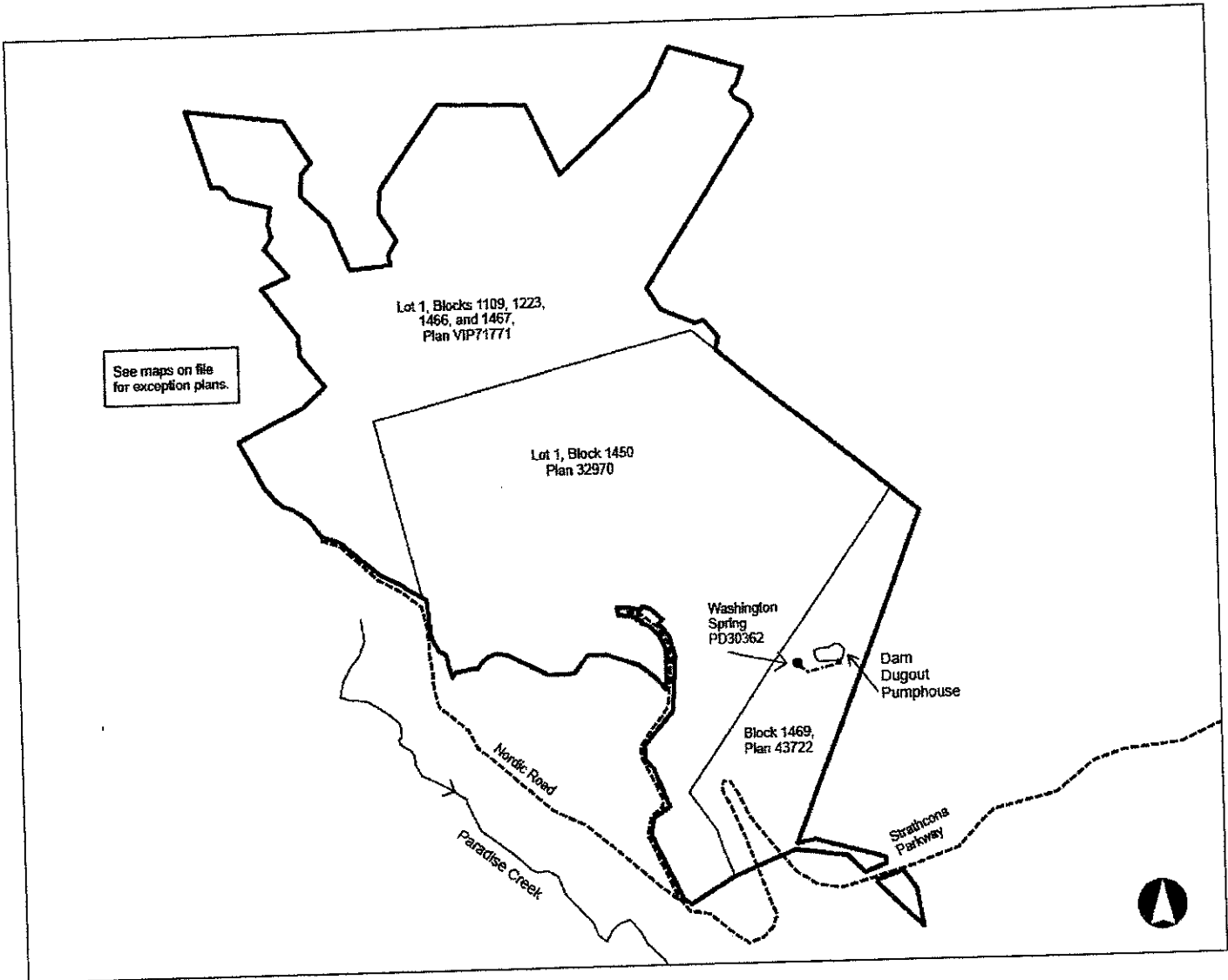
The owners of the land to which this licence is appurtenant are hereby authorized to divert and store water as follows:

- a) The stream on which the rights are granted is Washington Spring, and storage is in a dugout.
- b) The point of diversion is located as shown on the attached plan.
- c) The date from which this licence shall have precedence is June 27, 2007.
- d) The purpose for which this licence is issued is storage (non-power).
- e) The maximum quantity of water which may be diverted and held in storage is 16,300 cubic metres per year.
- f) The period of the year during which the water may be held in storage is the whole year with diversion into storage from November 1 to July 31, and the period during which the stored water may be used to support Conditional Water Licence C132513 is November 1 to July 31.
- g) The land upon which the water is to be used and to which this licence is appurtenant is Lot 1, Block 1450, Plan 32970, except part in Plans 33031, 44162, VIP55683, VIP57885, VIP61190, VIP61590, VIP62680, VIP63820, VIP64956, VIP74436 and VIP82854; Block 1469 shown included in Plan 43722, except part in Plan VIP61590; Lot 1 of Block 1109, 1223, 1466 and 1467, Plan VIP71771, except part in Plan VIP80882 and VIP87931, all within Comox District.
- h) The authorized works are dam, dugout, pumphouse and pipe which shall be located approximately as shown on the attached plan.
- i) The construction of the said works has been completed and the water is being used. The licensee shall continue to make regular beneficial use of the water in a manner authorized herein.
- j) The dam authorized under clause (h) is subject to the Dam Safety Regulations and shall be designed, constructed and maintained to the satisfaction of a Dam Safety Officer under the *Water Act* and in accordance with the Canadian Dam Association Guidelines.
- k) This licence is issued in substitution of Conditional Water Licence C122995 in part.


