## *Water Sustainability Act*

### CONDITIONAL WATER LICENCE


The Corporation of Delta is hereby authorized to divert, use and store water as follows:

- a) The streams on which the rights are granted are Tasker Road Ditch (aka 80th Street Ditch), 96th Street Ditch, Alexander Road Ditch, Burns Bog Ditch and 72nd Street Ditch and storage is within the Burns Bog Conservation area.
- b) Storage is within the Burns Bog Conservation area as outlined in green and the points of diversion are located, both as shown on the attached plans.
- c) The date from which this licence shall have precedence is October 25, 2013.
- d) The purpose for which this licence is issued is Conservation (Stored Water) and Conservation (Construct Works).
- e) The maximum quantity of water which may be diverted for Conservation (Stored Water) purpose for the four control weirs is 7,300 cubic meters a year at Tasker Road Ditch (PD286241), 34,000 cubic meters a year at 96th Street Ditch (PD186237), 3,000 cubic meters a year at Alexander Road Ditch (PD186238) and 3,400 cubic meters a year at Burns Bog Ditch (PD186239). The maximum quantity of water which may be diverted for Conservation (Construct Works) purpose for the two flow monitoring weirs is total flow at Tasker Road Ditch (PD187690) and at 72nd Street Ditch (PD186589).
- f) The period of the year during which the water may be used is the whole year.
- g) The land upon which the water is to be used and to which this licence is appurtenant is the conservation project of Burns Bog of the licensee in which the works are located within the Ministry of Transportation and Infrastructure Highway 17 Right of Way in the vicinity of Lot 24, District Lot 133, Group 2, New Westminster District, Plan 852 and in the vicinity of Lot 1, District Lot 130, Group 2, New Westminster District, Plan EPP4430; Corporation of Delta 80th Street Right of Way and Lot 1, District Lot 130, Group 2, New Westminster District, Plan EPP4430; and the Corporation of Delta 72nd Street Right of Way in the vicinity of that part of Parcel "D" (EP 2515), District Lot 437, Group 2, New Westminster District, Plan 64775.
- h) The authorized works are four control weirs and two flow monitoring weirs which shall be located approximately as shown on the attached plans.

- i) The construction of all the said works, except one flow monitoring weir, has been completed and the water is being used. The licensee shall continue to make regular beneficial use of the water in a manner authorized herein.

The construction of the flow monitoring weir shall be completed and the water shall be beneficially used prior to December 31, 2019. Thereafter, the licensee shall continue to make regular beneficial use of the water in the manner authorized herein

- j) This licensee shall keep records on actual water use as directed by an Engineer under the *Water Sustainability Act* and have all records available for all weirs authorized under this licence.
