## *Water Act*


### CONDITIONAL WATER LICENCE

The owner(s) of the land to which this licence is appurtenant is/are hereby authorized to divert and use water as follows:

- a) The stream on which the rights are granted is Welland Creek.
- b) The points of diversion and re-diversion are located as shown on the attached plan.
- c) The date from which this licence shall have precedence is May 21, 1968.
- d) The purposes for which this licence is issued are irrigation, domestic and industrial (stockwatering).
- e) The maximum quantity of water which may be diverted for irrigation purpose is 4934 cubic meters (4 acre feet) per annum, for domestic purpose is 2.273 cubic meters per day and for industrial (stockwatering) purpose is 4.546 cubic meters per day.
- f) The period of the year during which the water may be used for irrigation purpose is April 1st to September 30th and for domestic and industrial (stockwatering) purpose is the whole year.
- g) The land upon which the water is to be used and to which this licence is appurtenant is Lot 9, Section 30, Township 22, Range 20, and Section 25, Township 22, Range 21 W6M, KDYD District Plan EPP44184 of which .08 hectares (2 acres) may be irrigated.
- h) The authorized works are diversion structure, irrigation system, trough, and a screened intake which shall be located approximately as shown on the attached plan.
- i) The construction of the said works shall be completed and the water shall be beneficially used prior to December 31, 2018. Thereafter, the licensee shall continue to make regular beneficial use of the water in the manner authorized herein.
- j) This licence is issued under the Water Act (the Act). The exercise of rights under the licence is subject to the Act and its regulations, the terms and conditions of the licence, orders under the Act and the rights of licensees whose rights have precedence on the stream. The licensee must comply with all such requirements, as well as the provisions of all other applicable enactments. In exercising rights under the licence, the licensee must

exercise reasonable care to avoid damaging land, works, trees or other property, and must make full compensation to the owners for damage or loss resulting from construction, maintenance, use, operation or failure of the works.

- k) Any water diverted and used for irrigation purpose pursuant to this licence during the period from July 1st to September 30th, must be taken from storage provided in the reservoir authorized under Conditional Water Licence Number C132687 or any licence issued in substitution thereof.
- l) The rights granted hereunder are exercisable only during such times as the works authorized under Conditional Water Licence Number C132687, or any licence issued in substitution thereof is being maintained and operated to the satisfaction of an Engineer under the Water Act.
- m) This licence authorizes the use of water for domestic purpose in 1 dwelling located approximately as shown on the attached plan.
- n) This Licence is issued in substitution of Conditional Water Licence Number C063659 ", in part."
