

Province of British Columbia Water Sustainability Act

CONDITIONAL WATER LICENCE

The owner(s) of the land to which this licence is appurtenant is/are hereby authorized to divert and use water as follows:

- a) The stream on which the rights are granted is North Thompson River.
- b) The point of diversion is located as shown on the attached plan.
- c) The date from which this licence shall have precedence is December 15, 2014.
- d) The purpose for which this licence is issued is processing and manufacturing.
- e) The maximum quantity of water which may be diverted for processing and manufacturing purpose is 1295 cubic meters per day at a rate not to exceed 0.015 cubic meters per second.
- f) The period of the year during which the water may be used is the whole year.
- g) The land upon which the water is to be used and to which this licence is appurtenant is that part of Lot A lying north and west of that part thereof shown on Plan H68; District Lots 320 and 324 and of Section 3 Township 22 Range 17 west of the 6th Meridian Kamloops Division Yale District Plan 10881.
- h) The authorized works are screened intake, pumphouse, flow measuring device, distribution system, reservoir, fire suppression system, and pipe which shall be located approximately as shown on the attached plan.
- i) The construction of the said works shall be completed and the water shall be beneficially used prior to December 31, 2019. Thereafter, the licensee shall continue to make regular beneficial use of the water in the manner authorized herein.
- j) This licence is issued under the *Water Sustainability Act* (the Act). The exercise of rights under the licence is subject to the Act and its regulations, the terms and conditions of the licence, orders under the Act and the rights of licensees whose rights have precedence on the stream or on an aquifer. The licensee must comply with all such requirements, as well as the provisions of all other applicable enactments. In exercising rights under the licence, the licensee must exercise reasonable care to avoid damaging land, works, trees or other property, and must make full compensation to the owners for damage or loss resulting from

construction, maintenance, use, operation or failure of the works.

- k) The licensee shall install a flow measuring device to the satisfaction of an Engineer under the *Water Sustainability Act*.
- 1) The licensee shall retain flow meter records for inspection upon request by an Engineer under the *Water Sustainability Act*.
- m) The works authorized under clause (h) hereof shall be maintained to the satisfaction of an Engineer under the *Water Sustainability Act*.
- n) The diversion of water authorized under this licence may be restricted or prohibited at any time by an Order in writing under the *Water Sustainability Act*, in order to maintain a minimum flow in a stream for the preservation of fish or for maintaining the health of aquatic ecosystems.
