Water Sustainability Act

CONDITIONAL WATER LICENCE

The owner of the land to which this licence is appurtenant are hereby authorized to divert and use water as follows:

- a) The stream on which the rights are granted is Anderson Creek.
- b) The points of diversion and re-diversion are located as shown on the attached plan.
- c) The date from which this licence shall have precedence is November 9, 1883.
- d) The purpose for which this licence is issued is Irrigation.
- e) The maximum quantity of water which may be diverted for Irrigation is 61797.4482 cubic metres (50.1 acre feet) per annum.
- f) The period of the year during which the water may be used is the 1st of October to 1st of June, but may be re-diverted and used from Edith Lake between the 1st of April to 30th of September.
- g) The land upon which the water is to be used and to which this licence is appurtenant is Lot A District Lot 453 and of Section 30 Township 19 Range 17 West of the 6th Meridian Kamloops Division Yale District Plan 18669 except Plans KAP51391 and KAP60271 of which 6.758 hectares (16.7 acres) may be irrigated.
- h) The authorized works are diversion structure pipe, pumps and sprinklers which shall be located approximately as shown on the attached plan.
- i) The construction of the said works has been completed and the water is being used. The licensee shall continue to make regular beneficial use of the water in a manner authorized herein.
- j) This licence is issued under the *Water Sustainability Act* (the Act). The exercise of rights under the licence is subject to the Act and its regulations, the terms and conditions of the licence, orders under the Act and the rights of licensees whose rights have precedence on the stream. The licensee must comply with all such requirements, as well as the provisions of all other applicable enactments. In exercising rights under the licence, the licensee must exercise reasonable care to avoid damaging land, works, trees or other property, and must

make full compensation to the owners for damage or loss resulting from construction, maintenance, use, operation or failure of the works.

- k) Any water used pursuant to this licence during the period from the 1st of April to the 30th of September must be taken from storage provided in the reservoir authorized under C130933 or any licence issued in substitution thereof.
- l) This licence is supplementary to Conditional Water Licence 130927 (Peterson Creek). The maximum quantity of water which may be diverted under this licence is 61797.45 cubic meters (50.1 acre-feet) which together with the quantity available under Conditional Water Licence 130927 will provide 255,824.1668 cubic metres (207.4 acre feet) per annum.
- m) This Licence is issued in substitution of Conditional Water Licence 130930.
