## *Water Sustainability Act*

### CONDITIONAL WATER LICENCE

The owners of the land to which this licence is appurtenant are hereby authorized to divert and use water as follows:

- a) The stream on which the rights are granted is Okanagan Lake.
- b) The point of diversion is located as shown on the attached plan.
- c) The date from which this licence shall have precedence is April 20, 2016.
- d) The purpose for which this licence is issued is Domestic.
- e) The maximum quantity of water which may be diverted for Domestic is 2 m<sup>3</sup>/day.
- f) The period of the year during which the water may be used is January 1 to December 31.
- g) The land upon which the water is to be used and to which this licence is appurtenant is Lot 2 Section 14 Township 13 Osoyoos Division Yale District Plan 24730.
- h) The authorized works are deep intake (not constructed), pipe (not constructed), pump (not constructed), screened Intake (not constructed) which shall be located approximately as shown on the attached plan.
- i) The construction of the said works shall be completed and the water shall be beneficially used prior to December 31, 2019. Thereafter, the licensee shall continue to make regular beneficial use of the water in the manner authorized herein.
- j) To construct the works authorized under clause (h) of this licence, the licensee must ensure the installation of the intake water line will be carried out either by:
  - (1) the directional drilling of the intake line to avoid damaging sensitive habitat; or
  - (2) following the water line installation plan as approved by an Engineer use the *Water Sustainability Act* and produced by a Qualified Professional which considers both biological values on site, and the degree to which the proposed work will impact those values.
- k) This licence authorizes the use of water for domestic purpose in one (1) dwelling located approximately as shown on the attached plan.

- l) The works authorized under clause (h) hereof shall be constructed to operate within a lake elevation of 340.41 to 343.09 metres (1116.8 to 1125.3 feet), Geodetic Survey of Canada datum.
- m) The licence shall install a flow metering or other measuring device to the satisfaction of an Engineer under the *Water Sustainability Act*.
- n) The licensee shall retain flow meter/measurement records for inspection upon request by an Engineer under the *Water Sustainability Act*.
- o) This licence is issued under the *Water Sustainability Act* (the Act). The exercise of rights under the licence is subject to the Act and its regulations, the terms and conditions of the licence, orders under the Act and the rights of licensees whose rights have precedence on the stream or on an aquifer. The licensee must comply with all such requirements, as well as the provisions of all other applicable enactments. In exercising rights under the licence, the licensee must exercise reasonable care to avoid damaging land, works, trees or other property, and must make full compensation to the owners for damage or loss resulting from construction, maintenance, use, operation or failure of the works.
