

Province of British Columbia Water Sustainability Act

CONDITIONAL WATER LICENCE

The owner(s) of the land to which this licence is appurtenant is/are hereby authorized to divert and use water as follows:

- a) The stream on which the rights are granted is North Thompson River.
- b) The point of diversion is located as shown on the attached plan.
- c) The date from which this licence shall have precedence is March 14, 2016.
- d) The purposes for which this licence is issued are Livestock and animal stockwatering and Private irrigation.
- e) The maximum quantity of water which may be diverted for Livestock and animal stockwatering is 692.655 cubic metres per year and the maximum quantity which may be used for Private irrigation is 259,075 cubic metres per year.
- f) The period of the year during which the water may be used for Livestock and animal stockwatering and for Private irrigation is April 1 to September 30.
- g) The land upon which the water is to be used and to which this licence is appurtenant is District Lot 1812, Kamloops Division Yale District, except (1) Parcels 1 and 2 on Plan B49 (2) PlansB4972, 22338, H13322, and KAP 69442, of which 34 hectares may be irrigated.
- h) The authorized works are diversion structure, screened intake, pumphouse, flow measuring device, pipe, sprinklers, and trough which shall be located approximately as shown on the attached plan.
- i) The construction of the said works shall be completed and the water shall be beneficially used prior to December 31, 2019. Thereafter, the licensee shall continue to make regular beneficial use of the water in the manner authorized herein.
- j) This licence is issued under the *Water Sustainability Act* (the Act). The exercise of rights under the licence is subject to the Act and its regulations, the terms and conditions of the licence, orders under the Act and the rights of licensees whose rights have precedence on the stream or on an aquifer. The licensee must comply with all such requirements, as well as the provisions of all other applicable enactments. In exercising rights under the licence,

the licensee must exercise reasonable care to avoid damaging land, works, trees or other property, and must make full compensation to the owners for damage or loss resulting from construction, maintenance, use, operation or failure of the works.

- k) The diversion of water authorized under this licence may be restricted or prohibited at any time by an Order in writing under the *Water Sustainability Act*, in order to maintain a minimum flow in a stream for the preservation of fish or for maintaining the health of aquatic ecosystems.
- 1) The licensee shall install a flow measuring device to the satisfaction of an Engineer under the *Water Sustainability Act*.
- m) The licensee shall retain flow meter records for inspection upon request by an Engineer under the *Water Sustainability Act*.
- n) The industrial livestock and animal purpose authorized by this licence is for use outside the wetted perimeter of any mapped source in a trough located approximately as shown on the attached plan.
