

Province of British Columbia Water Sustainability Act

CONDITIONAL WATER LICENCE

The owners of the land to which this licence is appurtenant are hereby authorized to divert and use water as follows:

- a) The stream on which the rights are granted is Dickey Creek.
- b) The point of diversion is located as shown on the attached plan.
- c) The date from which this licence shall have precedence is March 17, 1959.
- d) The purposes for which this licence is issued are irrigation, industrial (livestock) and domestic.
- e) The maximum quantity of water which may be diverted for irrigation purpose is 72,378.55025 cubic metres per year, for industrial (livestock) purpose is 2.27305 cubic metres per day and for domestic purpose is 2.27305 cubic metres per day.
- f) The period of the year during which the water may be used for irrigation purpose is April 1 to September 30, for industrial (livestock) purpose is the whole year and for domestic purpose is the whole year.
- g) The land upon which the water is to be used and to which this licence is appurtenant is Lot 1 District Lots 162, 1303 and 3099 Lillooet District Plan 32740 except Plans KAP55290 and KAP62233, of which 7.916 hectares may be irrigated.
- h) The authorized works are a diversion structure, pipes, trough, sprinkler system and flow measuring device which shall be located approximately as shown on the attached plan.
- i) The construction of the said works has been completed and the water is being beneficially used. The licensee shall continue to make regular beneficial use of the water in a manner authorized herein.
- j) This licence is issued under the *Water Sustainability Act* (the Act). The exercise of rights under the licence is subject to the Act and its regulations, the terms and conditions of the licence, orders under the Act and the rights of licensees whose rights have precedence on the stream or on an aquifer. The licensee must comply with all such requirements, as well as the provisions of all other applicable enactments. In exercising rights under the licence,

the licensee must exercise reasonable care to avoid damaging land, works, trees or other property, and must make full compensation to the owners for damage or loss resulting from construction, maintenance, use, operation or failure of the works.

- k) The industrial stockwatering purpose authorized by this licence is for use outside the wetted perimeter of the source in a trough located approximately as shown on the attached plan.
- 1) The licensee shall install a flow measuring device to the satisfaction of an Engineer under the *Water Sustainability Act*.
- m) The licensee shall retain flow meter records for inspection upon request by an Engineer under the *Water Sustainability Act*.
- n) This licence authorizes the use of water for domestic purpose in one dwelling located approximately as shown on the attached plan.
- o) The licensee shall submit to the Comptroller of Water Rights, Water Manager, or an Engineer a Beneficial Use Declaration and a drawing prepared to the water licence application drawing standards showing the point of diversion, area of beneficial use, all associated works, and the legal boundaries of the appurtenant land, on or before the 31st day of December, 2017.
- p) This Licence is issued in substitution of Conditional Water Licences 129299 and 129300.
