

## Province of British Columbia Water Sustainability Act

## CONDITIONAL WATER LICENCE

The owner of the land to which this licence is appurtenant are hereby authorized to divert and water as follows:

- a) The stream on which the rights are granted is Delorne Creek.
- b) The point of diversion is located as shown on the attached plan.
- c) The date from which this licence shall have precedence is February 29, 2016.
- d) The purpose for which this licence is issued is domestic.
- e) The maximum quantity of water which may be diverted for domestic use is 4 cubic metres per day.
- f) The period of the year during which the water may be used is January 1 to December 31.
- g) The land upon which the water is to be used and to which this licence is appurtenant is THAT PART OF THE FRACTIONAL NORTH 1/2 OF SECTION 8 LYING SOUTH OF THE SHUSWAP RIVER AS SHOWN ON PLAN OF THE SOUTHWEST 1/4 OF SAID TOWNSHIP DATED AT OTTAWA 03/05/1916; TOWNSHIP 19 RANGE 6 WEST OF THE 6TH MERIDIAN KAMLOOPS DIVISION YALE DISTRICT.
- h) The authorized works are screened intake (partly constructed), pipe (partly constructed) and flow measuring device (not constructed) which shall be located approximately as shown on the attached plan.
- i) The construction of the said works shall be completed and the water shall be beneficially used prior to December 31, 2019. Thereafter, the licensee shall continue to make regular beneficial use of the water in the manner authorized herein.
- j) This licence authorizes the use of water for domestic purpose in two dwellings located approximately as shown on the attached plan.
- k) The diversion of water authorized under this licence may be restricted or prohibited at any time by an Order in writing under the *Water Sustainability Act*, in order to maintain a minimum flow in a stream.

- 1) The licensee shall install a flow metering or other measuring device to the satisfaction of an Engineer under the *Water Sustainability Act*.
- m) The licensee shall retain flow meter/measurement records for inspection upon request by an Engineer under the *Water Sustainability Act*.
- n) This licence is issued under the *Water Sustainability Act* (the Act). The exercise of rights under the licence is subject to the Act and its regulations, the terms and conditions of the licence, orders under the Act and the rights of licensees whose rights have precedence on the stream or on an aquifer. The licensee must comply with all such requirements, as well as the provisions of all other applicable enactments. In exercising rights under the licence, the licensee must exercise reasonable care to avoid damaging land, works, trees or other property, and must make full compensation to the owners for damage or loss resulting from construction, maintenance, use, operation or failure of the works.
