

Province of British Columbia Water Sustainability Act

CONDITIONAL WATER LICENCE

The holder of Placer Claims No. 954775 and 965829 to which this licence is appurtenant is hereby authorized to divert and use water as follows:

- a) The stream on which the rights are granted is Unnamed Lake.
- b) The point of diversion is located as shown on the attached plan.
- c) The date from which this licence shall have precedence is November 11, 2015.
- d) The purpose for which this licence is issued is Mining: Placer.
- e) The maximum quantity of water which may be diverted for placer mining is 244,944 per year at a maximum rate of 0.0630 cubic metres per second.
- f) The period of the year during which the water may be used is May 1 to October 15.
- g) The mine upon which the water is to be used and to which this licence is appurtenant is the mining project of the licensee within Mineral Tenure Numbers: PC 954775 and 965829.
- h) The authorized works are diversion structure with screened intake, pumps, pipes, settling ponds and wash plant which shall be located within Mineral Tenure Numbers: PC 954775 and 965829, Cariboo Mining District.
- i) The construction of the said works shall be completed and the water shall be beneficially used prior to December 31, 2019. Thereafter, the licensee shall continue to make regular beneficial use of the water in the manner authorized herein.
- j) This licence is issued under the Water Sustainability Act (the Act). The exercise of rights under the licence is subject to the Act and its regulations, the terms and conditions of the licence, orders under the Act and the rights of licensees whose rights have precedence on the stream or on an aquifer. The licensee must comply with all such requirements, as well as the provisions of all other applicable enactments. In exercising rights under the licence, the licensee must exercise reasonable care to avoid damaging land, works, trees or other property, and must make full compensation to the owners for damage or loss resulting from construction, maintenance, use, operation or failure of the works.



- k) The diversion of water authorized under this licence may be restricted or prohibited at any time by an Order in writing under the Water Sustainability Act, in order to maintain a minimum flow in a stream for the preservation of fish or for maintaining the health of aquatic ecosystems.
- 1) This licence is valid only as long as the Placer Claims No. 954775 and 965829 are in good standing.
