

Province of British Columbia Water Sustainability Act

CONDITIONAL WATER LICENCE

The owner of the land to which this licence is appurtenant is hereby authorized to store water as follows:

- a) The source on which the rights are granted is Jones Creek and storage is in Jones Lake.
- b) The storage site is located as shown on the attached plan.
- c) The date from which this licence shall have precedence is December 8, 1926.
- d) The purpose for which this licence is issued is stream storage: non-power, irrigation: private and livestock & animal: livestock watering.
- e) The maximum quantity of water which may be diverted to stream storage: non-power is 151,472 cubic meters per year (122.8 acre feet) the maximum quantity which may be used for irrigation: private is148,495 cubic meters per year and livestock & animal: livestock watering is 4.12 cubic meters per day.
- f) The period of the year during which the water may be used is October 1 to June 15.
- g) The land upon which the water is to be used and to which this licence is appurtenant is as set out in Conditional Water Licence 133454.
- h) The authorized works are a dam which shall be located approximately as shown on the attached plan.
- i) The construction of the said works has been completed and the water is being beneficially used. The licensee shall continue to make regular beneficial use of the water in a manner authorized herein.
- j) Any reconstruction of the storage work shall not be commenced until plans have been submitted to and written leave to commence construction granted by the Engineer under the Water Sustainability Act or the Regional Water Manager.
- k) This licence is supplementary to Conditional Water Licence 133454. The maximum quantity of water which may be diverted under this licence is the quantity which together with the quantity available under Conditional Water Licence 133454 will provide 151,472



- 1) This licence is issued under the *Water Sustainability Act* (the Act). The exercise of rights under the licence is subject to the Act and its regulations, the terms and conditions of the licence, orders under the Act and the rights of licensees whose rights have precedence on the stream or on an aquifer. The licensee must comply with all such requirements, as well as the provisions of all other applicable enactments. In exercising rights under the licence, the licensee must exercise reasonable care to avoid damaging land, works, trees or other property, and must make full compensation to the owners for damage or loss resulting from construction, maintenance, use, operation or failure of the works.
- m) This licence is issued in substitution of Final Water Licence 124286 in part.
