

## Province of British Columbia Water Sustainability Act

## CONDITIONAL WATER LICENCE

The owners of the land to which this licence is appurtenant are hereby authorized to divert and use water as follows:

- a) The stream on which the rights are granted is Jones Creek.
- b) The points of diversion are located as shown on the attached plan.
- c) The date from which this licence shall have precedence is July 13, 1905.
- d) The purposes for which this licence is issued are livestock & animal: stockwatering and irrigation: private.
- e) The maximum quantity of water which may be diverted for livestock & animal: stockwatering is 4.1 cubic meters per day and the maximum quantity which may be used for irrigation: private is 148,503 cubic meter per year.
- f) The period of the year during which the water may be used for livestock & animal: stockwatering is the whole year and the period of the year during which the water may be used for irrigation: private is April 1 to September 30.
- g) The land upon which the water is to be used and to which this licence is appurtenant is DISTRICT LOT 27 CARIBOO DISTRICT EXCEPT PART IN PLAN EPP50330 of which 24.6 hectares may be irrigated.
- h) The authorized works are diversion structure, pipe, pump, ditch, and trough which shall be located approximately as shown on the attached plan.
- i) The construction of the said works has been completed and the water is being beneficially used. The licensee shall continue to make regular beneficial use of the water in a manner authorized herein.
- j) The industrial livestock & animal: stockwatering purpose authorized under this licence is for use outside the wetted perimeter of the source in a trough located approximately as shown on the attached plan.

- k) This licence is issued under the *Water Sustainability Act* (the Act). The exercise of rights under the licence is subject to the Act and its regulations, the terms and conditions of the licence, orders under the Act and the rights of licensees whose rights have precedence on the stream or on an aquifer. The licensee must comply with all such requirements, as well as the provisions of all other applicable enactments. In exercising rights under the licence, the licensee must exercise reasonable care to avoid damaging land, works, trees or other property, and must make full compensation to the owners for damage or loss resulting from construction, maintenance, use, operation or failure of the works.
- 1) This licence is issued in substitution of Conditional Water Licence 124082 in part.
