

Province of British Columbia Water Sustainability Act

CONDITIONAL WATER LICENCE

The owner of the land to which this licence is appurtenant is hereby authorized to store water as follows:

- a) The streams on which the rights are granted are John Frank Creek, and the reservoirs are Horseshoe Lake, Frank Lake, and Lake C.
- b) The storage site is located as shown on the attached plan.
- c) The date from which this licence shall have precedence is December 31, 1915.
- d) The purpose for which this licence is issued is stream storage: non-power.
- e) The maximum quantity of water which may be stored under this licence is 165,903.06 cubic meters per year.
- f) The period of the year during which water may be diverted into storage is October 1 to June 15, and the stored water may be used for stream storage: non-power purposes during October 1 to June 15.
- g) The land upon which the water is to be used and to which this licence is appurtenant is as set out in Conditional Licence 58660 or any licence issued in substitution therein.
- h) The authorized works are a saddle dam and dams which shall be located approximately as shown on the attached plan.
- i) The construction of the said works has been completed and the water is being beneficially used. The licensee shall continue to make regular beneficial use of the water in a manner authorized herein.
- j) This licence is issued under the *Water Sustainability Act* (the Act). The exercise of rights under the licence is subject to the Act and its regulations, the terms and conditions of the licence, orders under the Act and the rights of licensees whose rights have precedence on the stream or on an aquifer. The licensee must comply with all such requirements, as well as the provisions of all other applicable enactments. In exercising rights under the licence, the licensee must exercise reasonable care to avoid damaging land, works, trees or other property, and must make full compensation to the owners for damage or loss resulting from construction, maintenance, use, operation or failure of the works.



- k) The dam authorized under clause (h) is subject to the Dam Safety Regulation and shall be designed, constructed and maintained to the satisfaction of a Dam Safety Officer under the *Water Sustainability Act* and in accordance with the Canadian Dam Association Guidelines.
- Final construction drawings, Operations, Maintenance and Surveillance Manual and Dam Emergency Plan must be submitted to the Dam Safety Officer during the first year of operation.
- m) Following the substantial completion of construction, filling of the reservoir must not commence until written leave to commence diversion is given by an Dam Safety Officer under the *Water Sustainability Act*.
- n) This Licence is issued in substitution of Conditional Water Licence 58661.
