

Province of British Columbia Water Sustainability Act

CONDITIONAL WATER LICENCE

The owner of the land to which this licence is appurtenant is hereby authorized to divert and use water as follows:

- a) The stream on which the rights are granted is McCutcheon Brook.
- b) The point of diversion is located as shown on the attached plan.
- c) The date from which this licence shall have precedence is July 9, 2013.
- d) The purpose for which this licence is issued is camps & public facilities.
- e) The maximum quantity of water which may be diverted is 9.0 cubic meters per day (2000 gallons per day).
- f) The period of the year during which the water may be used is January 1 to December 31.
- g) The land upon which the water is to be used and to which this licence is appurtenant is District Lot 11655, Cariboo District (PID 015-290-573).
- h) The authorized works are pipe, diversion structure, and screened intake which shall be located approximately as shown on the attached plan.
- i) The construction of the said works shall be completed and the water shall be beneficially used prior to December 31, 2019. Thereafter, the licensee shall continue to make regular beneficial use of the water in the manner authorized herein.
- j) This licence authorizes the use of water for domestic purpose in 4 dwellings located approximately as shown on the attached plan.
- k) The diversion of water authorized under this licence may be restricted or prohibited at any time by an Order in writing under the *Water Sustainability Act*, in order to maintain a minimum flow in a stream for the preservation of fish or for maintaining the health of aquatic ecosystems.
- The rights granted under this licence are subject to a water reserve established by Order in Council No. 1043 dated July 25, 1992.



m) This licence is issued under the *Water Sustainability Act* (the Act). The exercise of rights under the licence is subject to the Act and its regulations, the terms and conditions of the licence, orders under the Act and the rights of licensees whose rights have precedence on the stream or on an aquifer. The licensee must comply with all such requirements, as well as the provisions of all other applicable enactments. In exercising rights under the licence, the licensee must exercise reasonable care to avoid damaging land, works, trees or other property, and must make full compensation to the owners for damage or loss resulting from construction, maintenance, use, operation or failure of the works.
