Water Sustainability Act

WATER LICENCE

The owner(s) of the land to which this licence is appurtenant is/are hereby authorized to divert and use water as follows:

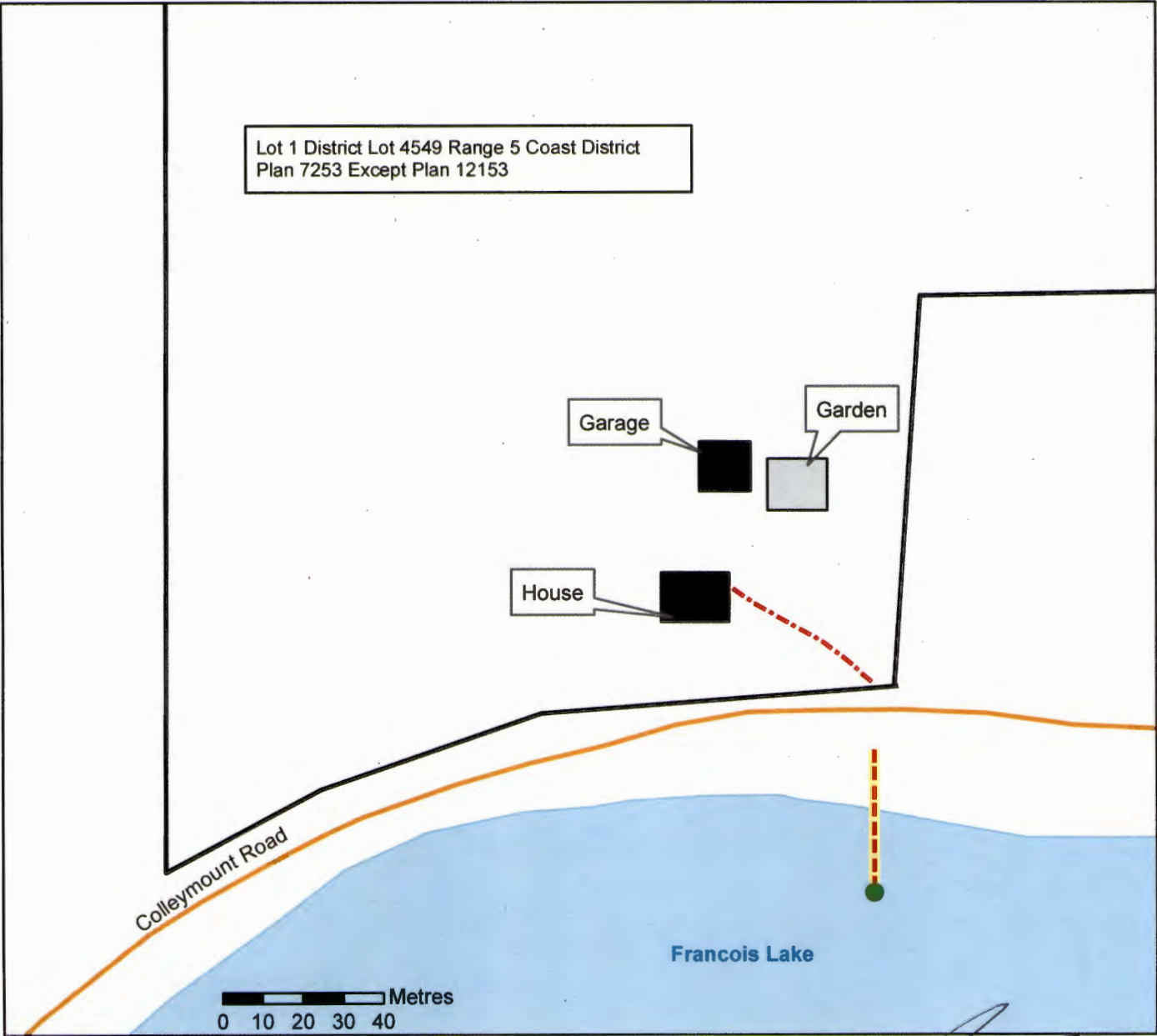
- a) The stream on which the rights are granted is Francois Lake.
- b) The point of diversion is located approximately as shown on the attached plan.
- c) The date from which this licence shall have precedence is October 18, 2016.
- d) The purpose for which this licence is issued is domestic.
- e) The maximum quantity of water which may be diverted for domestic purposes is 2 cubic metres per day.
- f) The period of the year during which the water may be used is January 1 to December 31.
- g) The land upon which the water is to be used and to which this licence is appurtenant is Lot 1 District Lot 4549 Range 5 Coast District Plan 7253 Except Plan 12153.
- h) The authorized works are pipe, pump and screened intake which shall be located approximately as shown on the attached plan.
- i) The construction of the said works shall be completed and the water shall be beneficially used prior to January 1, 2020. Thereafter, the licensee shall continue to make regular beneficial use of the water in the manner authorized herein.
- j) To construct the works authorized under clause (h) of this licence, the licensee must:
 - (1) Submit a construction plan outlining the methodology proposed for the installation of the pipe, screened intake and pump.
 - (2) Prepare an Environmental Management Plan (refer to as the EMP) for the management and mitigation of construction impacts, which is to be to the satisfaction of a Water Manager under the Water Sustainability Act; and
 - (3) Obtain approval in writing of said plans from a Water Manager under the *Water Sustainability Act*.

- k) The works authorized under clause (h) hereof shall be maintained to the satisfaction of an Engineer under the *Water Sustainability Act*.
- l) The diversion of water authorized under this licence may be restricted or prohibited at any time by an Order in writing under the *Water Sustainability Act* in order to maintain a minimum level in a stream.
