## *Water Sustainability Act*

### CONDITIONAL WATER LICENCE

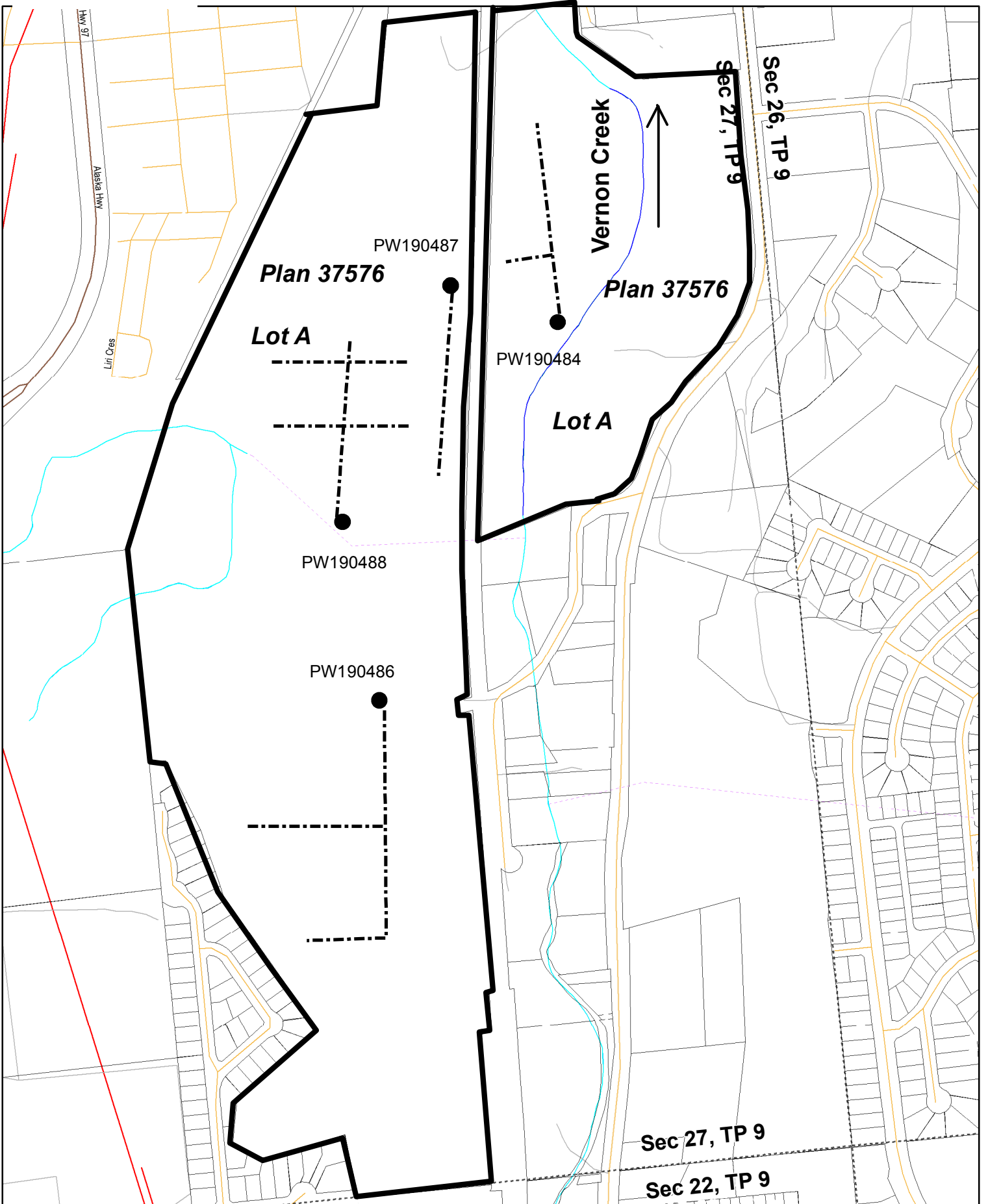
The owner of the land to which this licence is appurtenant is hereby authorized to divert and use water as follows:

- a) The aquifer on which the rights are granted is aquifer 346.
- b) The points of well diversion are located as shown on the attached plan.
- c) The date from which this licence shall have precedence is September 1, 1969.
- d) The purpose for which this licence is issued is lawn, fairway & garden.
- e) The maximum quantity of water which may be diverted is 126, 573 cubic metres per annum.
- f) The period of the year during which the water may be used is March 1 to October 31.
- g) The land upon which the water is to be used and to which this licence is appurtenant is Lot A Section 27 Township 9 Osoyoos Division Yale District Plan 37576 Except Plan KAP88620 of which 15.7 hectares may be irrigated.
- h) The authorized works are pipe, irrigation system and four wells which shall be located approximately as shown on the attached plan.
- i) The construction of the said works has been completed and the water is being beneficially used. The licensee shall continue to make regular beneficial use of the water in a manner authorized herein.
- j) The diversion of water authorized under this licence may be restricted or prohibited at any time by an Order in writing under the *Water Sustainability Act*, in order to maintain a minimum flow in a stream for the preservation of fish or for maintaining the health of aquatic ecosystems.

- k) This licence is supplementary to Conditional Water Licence 500066 or any licence issued in substitution thereof and the maximum quantity of water which may be diverted under this licence is the quantity which together with the quantity available under Conditional Water Licence 500066 or any licence issued in substitution thereof will provide 252,340 cubic metres per annum, at a combined instantaneous withdrawal rate not to exceed 75 litres per second.
- l) This licensee shall keep records on the measurement of in-stream flows downstream of points of well diversion in Vernon Creek.
- m) The licence shall install a flow metering or other measuring device to the satisfaction of an Engineer under the *Water Sustainability Act*.
- n) The licensee shall retain flow meter/measurement records for inspection upon request by an Engineer under the *Water Sustainability Act*.
- o) This licence is issued under the *Water Sustainability Act* (the Act). The exercise of rights under the licence is subject to the Act and its regulations, the terms and conditions of the licence, orders under the Act and the rights of licensees whose rights have precedence on the stream or on an aquifer. The licensee must comply with all such requirements, as well as the provisions of all other applicable enactments. In exercising rights under the licence, the licensee must exercise reasonable care to avoid damaging land, works, trees or other property, and must make full compensation to the owners for damage or loss resulting from construction, maintenance, use, operation or failure of the works.
