Permit under the "Water Act, 1939," authorizing the Occupation of Crown Land

ESTATE OF G. A. BORTHWICK, DECEASED, of c/o The Royal Trust Co., 626 Pender St., West, Vancouver, B.C. the holder of a water licence authorizing the storage of water in Allan Lake is hereby authorized to occupy by flooding.

the following Crown land, namely:—

that portion of land lying around Allan Lake within Nehalliston Forest Reserve, Kamloops Division of Yale District, more particularly shown on Exhibit "A" and marked "R/W" having an area of 135 acres.

And, subject to the payment of royalty and stumpage under the "Forest Act" is authorized to destroy the timber on the said land by submerging it.

There is payable in respect of this permit an annual rental of \$13.50, which is subject to alteration at any time. Failure to pay the annual rental will render this permit subject to cancellation.

This permit is appurtenant to the land to which the aforesaid water licence is appurtenant.

The conditions relative to the rights granted under this permit are printed on the back of this form.

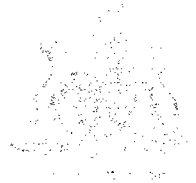

Permit under the "Water Act, 1939" and the
Occupation of Crown Lands Act

[Name], Notary Public for British Columbia, on this [Date] day of [Month], 19[Year], at [Location], in the Province of British Columbia, the following persons, who are known to me to be the persons named in the foregoing instrument, and who are of legal age and of sound mind, have appeared before me and have acknowledged to me that they have executed the foregoing instrument as their free and voluntary act and deed.

**CONDITIONS RELATIVE TO THE RIGHTS GRANTED
UNDER THIS PERMIT**

1. This permit is issued under section 20 of the "Water Act, 1939," and the rights hereby granted are subject at all times to the provisions of that Act and all Acts passed in amendment or substitution thereof and to all regulations from time to time made under any such Act.
2. There is reserved to the Crown the right to grant to other persons permits to occupy the land affected by this permit without compensation to the permittee or his successors in title.
3. In the event of any dispute arising at any time between the permittee and any owner of land adjacent to the land affected by this permit with respect to the area or boundaries of the land so affected, the licensee shall at his own expense, when so directed by the Deputy Minister of Lands, have the said land surveyed by a duly qualified surveyor, and shall likewise file with the Department of Lands and Forests at Victoria, B.C., a plan showing the result of the survey.
4. This permit and the rights granted hereunder are subject always to compliance by the permittee with the terms of his water licence, and if the rights granted under the said licence should at any time be suspended or terminated the rights granted under this permit are thereupon likewise suspended or terminated.
5. The amount of royalty and stumpage payable by the permittee in respect of the timber cut or destroyed by him shall be the sum or sums fixed by the Forest Service of the Government of British Columbia.

There is a copy of the permit as above described in my possession and I have caused a true and correct copy of the same to be made and filed in my office. In witness whereof I have hereunto set my hand and the seal of my office at [Location], this [Date] day of [Month], 19[Year].
