PERMIT UNDER THE "WATER ACT" AUTHORIZING THE OCCUPATION OF CROWN LAND.

WILMER WATERWORKS DISTRICT, of Wilmer, B.C.

the holder of a water licence authorizing the diversion of water from Bruce (Boulder) Creek is hereby authorized to occupy by constructing, maintaining and operating thereon the works authorized under the said water licence, and any licence which may be issued in substitution thereof.

the following Crown land, namely:- a portion of Lot 122, Lot 121, Lot 120, Lot 119, Lot 118 of Sublot 163A of District Lot 4596; Lot 117, Lot 116 of District Lot 1734; Sublot 160; Lot 115, Lot 114 of Lot 1735A; Lot 111 of Sublot 163A of District Lot 4596; Lot 104 of District Lot 379; Lot 211, Lot 210, Lot 207, Lot 208A, Lot 205 of Sublot 163B of District Lot 4596; Lot 201, Lot 192, Lot 191 of District Lot 7881 and Lot 183 of District Lot 7881, except for that part outlined in orange on Registered Plan 4538-I; Lot 170, Lot 169, Lot 168 of District Lot 376; Lot 199, Lot 193, Lot 200, Lot 194, Lot 179, Lot 180, Lot 181, Lot 182, Lot 195 of Sublot 163B of District Lot 4596; Lot 144, Lot 167, Lot 146, Lot 147, Lot 130, Lot 129, Lot 128, Lot 126, Lot 127, Lot 173, Lot 174, Lot 175, Lot 176, Lot 177, Lot 137, Lot 136, Lot 107, Lot 108, Lot 109, Lot 101, Lot 67, Lot 68 of District Lot 376; Lot 45, Lot 46, Lot 49 of District Lot 375, being 73,300 feet in length, 15 feet in width, the location of which is shown approximately on the plan attached to the said water licence and marked "R/W"

having an area of 25.24 acres.

And, subject to the payment of royalty, stumpage, and other compensation as provided under Condition 5, is authorized to cut and remove from the said land any timber the removal of which is necessary to permit the construction of the said works.

There is payable in respect of this permit an annual rental of \$13.00, which is subject to alteration at any time. Failure to pay the annual rental will render this permit subject to cancellation.

This permit is appurtenant to the land to which the aforesaid water licence is appurtenant.

The conditions relative to the rights granted under this permit are printed on the back of this form.

Conditional Licence No. 21145 PERMIT OVER CROWN LAND No. 3723

**CONDITIONS RELATIVE TO THE RIGHTS GRANTED UNDER THIS PERMIT.**

1. This permit is issued under section 20 of the "Water Act", and the rights hereby granted are subject at all times to the provisions of that Act and all Acts passed in amendment or substitution thereof and to all regulations from time to time made under any such Act.

2. There is reserved to the Crown the right to grant to other persons permits to occupy the land affected by this permit without compensation to the permittee or his successors in title.

3. In the event of any dispute arising at any time between the permittee and any owner of land adjacent to the land affected by this permit with respect to the area or boundaries of the land so affected, the licensee shall at his own expense, when so directed by the Deputy Minister of Lands, have the said land surveyed by a duly qualified surveyor, and shall likewise file with the Department of Lands and Forests at Victoria, B.C., a plan showing the result of the survey.

4. This permit and the rights granted hereunder are subjects always to compliance by the permittee with the terms of his water licence, and if the rights granted under the said licence should at any time be suspended or terminated the rights granted under this permit are thereupon likewise suspended or terminated.

5. The amount of stumpage, royalty, and (or) compensation payable to the Crown by the permittee in respect of trees, including merchantable or young growth, cut, removed, damaged, or destroyed by the permittee, shall be the sum or sums fixed by the Forest Service of the Province of British Columbia.
