Permit under the "Water Act" Authorizing the Occupation of Crown Land

R.Y. Devick and Frolek Cattle Co.Ltd., of Kamloops, B.C.

the holder of a water licence authorizing the storage of water in John Frank Lake, Frisken Lake, Bulman Lake and Lakes C and D are hereby authorized to occupy by flooding, maintaining and operating thereon the dams authorized under Final Water Licence No. 18846, and any licences which may be issued in substitution thereof,

the following Crown land, namely:— a portion of the North West 1/4 of Section 21, Section 22, the West 1/2 and South East 1/4 of Section 27, Section 28, South West 1/4 of Section 34, Township 17, and the South West 1/4 of Section 4 and South East 1/4 Section 5, Township 18, Range 16, West 6th Meridian, on which are situated 5 damsites containing 2 acres ± and a flooding Right-of-Way of 90 acres ±, the locations of which are shown on the plan attached to the said water licence,

having an area of 92 ± acres.

And, subject to the payment of royalty, stumpage, and other compensation as provided under Condition 5, is authorized to cut and remove from the said land any timber, the removal of which is necessary to maintain the dams and clear the land to be flooded.

There is payable in respect of this permit an annual rental of \$42.50, which is subject to alteration at any time. Failure to pay the annual rental will render this permit subject to cancellation.

This permit is appurtenant to the land to which the aforesaid water licence is appurtenant.

The conditions relative to the rights granted under this permit are printed on the back of this form.

Conditional Final Licence No. 18846 PERMIT OVER CROWN LAND No. 5829

**CONDITIONS RELATIVE TO THE RIGHTS GRANTED  
UNDER THIS PERMIT**

1. This permit is issued under section 23 of the "Water Act," and the rights hereby granted are subject at all times to the provisions of that Act and all Acts passed in amendment or substitution thereof and to all regulations from time to time made under any such Act.
2. There is reserved to the Crown the right to grant to other persons permits to occupy the land affected by this permit without compensation to the permittee or his successors in title.
3. In the event of any dispute arising at any time between the permittee and any owner of land adjacent to the land affected by this permit with respect to the area or boundaries of the land so affected, the licensee shall at his own expense, when so directed by the Deputy Minister of Lands, have the said land surveyed by a duly qualified surveyor, and shall likewise file with [REDACTED]  
the Department of Lands, Forests, and Water Resources at Victoria, B.C., a plan showing the result of the survey.
4. This permit and the rights granted hereunder are subject always to compliance by the permittee with the terms of his water licence, and if the rights granted under the said licence should at any time be suspended or terminated the rights granted under this permit are thereupon likewise suspended or terminated.
5. The amount of stumpage, royalty, and (or) compensation payable to the Crown by the permittee in respect of trees, including merchantable or young growth, cut, removed, damaged, or destroyed by the permittee, shall be the sum or sums fixed by the Forest Service of the Province of British Columbia.
