

## PERMIT UNDER THE WATER ACT AUTHORIZING THE OCCUPATION OF CROWN LAND

The holder of Conditional Water Licences 38192, 39156, 40050, 42042, 45174, 46845, 48444, 53284, <del>57155</del>, 58070, 60458, 62390, 66199, 66335, 66336, 66393, 70477, 70478, 103305, 103896, 103904, 104942, 109938, whose licences authorize the diversion of water from Okanagan Lake, is hereby authorized to occupy Crown land by (flooding and by) constructing, maintaining and operating thereon the works authorized under the said licences

- The Crown land which is authorized to be occupied under this permit is a (a) portion of Unsurveyed Crown land, Osoyoos Divsion Yale District, covered by the waters of Okanagan Lake, the location of which is shown approximately on the plan attached to the said water licences
- The approximate dimensions of the Crown Land authorized to be occupied under this permit are 1,100 feet (335.4 metres) in length by 15 feet (4.6 metres) in width, having an area of 0.38 acre (0.15 hectare).
- (c) Prior to the cutting, destruction of any timber, necessary to permit construction and maintenance of the said works and the permittee shall apply for and obtain a licence to cut timber from the Ministry of Forests, District Manager. The amount of stumpage, royalty and (or) compensation payable to the Crown in respect of trees, including merchantable or young growth, cut, removed, damaged, or destroyed by the permittee, shall be the sum or sums fixed by the Forest Service of the Province of British Columbia.
- (d) This permit is appurtenant to the land, mine or undertaking to the which the aforesaid water licence is appurtenant.
- This permit shall become void if the water licence with respect to which the (e) permit is issued should terminate, be abandoned or cancelled, or amended so as to render this permit unnecessary.
- This permit is issued and accepted on the understanding that the permittee (f) shall indemnify and save harmless the Government of the Province of British Columbia for all loss, damage to works, cost or expense suffered by the permittee by reason of the Crown Land or any portion thereof being submerged or damaged by erosion or otherwise affected by flooding.
- The holder of this permit shall not be entitled to compensation if the Crown (g) grants permits to other persons to occupy the land affected by this permit.
- In the event of a dispute at any time with respect to the area or boundaries (h) of the land affected by this permit, the holder shall, at his own expense, have the said land surveyed by a duly qualified surveyor.
- (i) This permit replaces Permit No. 21787.

(j) This permit is subject to the provisions of the Navigable Waters Protection
