## PERMIT UNDER THE WATER ACT AUTHORIZING THE OCCUPATION OF CROWN LAND

The holders of Conditional Water Licence 113399, whose licence authorize the diversion and use of water from Mabel Lake, are hereby authorized to occupy Crown land by constructing, maintaining and operating thereon the works authorized under the said licence.

- The Crown land which is authorized to be occupied under this permit is a portion of Crown land (a) which is described as foreshore and unsurveyed Crown land covered by the waters of Mabel Lake, the location of which is shown approximately on the amended planattached to the said water licence.
- The approximate dimensions of the Crown Land authorized to be occupied under this permit are 100 (b) feet (30.5 metres) in length by 15 feet (4.6 metres) in width, having an area of 0.03 acres (0.01 hectares).
- Prior to the cutting, destruction of any timber, necessary to permit construction and maintenance of (c) the said works, the permittee shall apply for and obtain a licence to cut timber from the Ministry of Forests, District Manager. The amount of stumpage, royalty and (or) compensation payable to the Crown in respect of trees, including merchantable or young growth, cut, removed, damaged, or destroyed by the permittee, shall be the sum or sums fixed by the Forest Service of the Province of British Columbia.
- This permit is appurtenant to the land, mine or undertaking to the which the aforesaid water licence is (d) appurtenant.
- This permit shall become void if the water licence with respect to which the permit is issued should (e) terminate, be abandoned or cancelled, or amended so as to render this permit unnecessary.
- This permit is issued and accepted on the understanding that the permittee shall indemnify and save (f) harmless the Government of the Province of British Columbia for all loss, damage to works, cost or expense suffered by the permittee by reason of the Crown Land or any portion thereof being submerged or damaged by erosion or otherwise affected by flooding.
- The holder of this permit shall not be entitled to compensation if the Crown grants permits to other (g) persons to occupy the land affected by this permit.
- In the event of a dispute at any time with respect to the area or boundaries of the land affected by this (h) permit, the holder shall, at his own expense, have the said land surveyed by a duly qualified surveyor.
- The annual rental for this permit \$6.00, which is subject to review and revision at any time at the (i) discretion of the Crown.
- This permit is subject to the provisions of the Navigable Waters Protection Act. **(j)**
- (k) This permit replaces Permit No. 20734.
