PERMIT AUTHORIZING THE OCCUPATION OF CROWN LAND SECTION 26

The Holder of Final Water Licence 121741 and Conditional Water Licence 121742 which authorize the diversion, storage and use of water from Cranberry Creek, is hereby authorized to occupy Crown Land by constructing, maintaining and operating thereon the works authorized under the said licences.

(a) The Crown Land which is authorized to be occupied under this permit is portions of Legal Subdivisions 3, 4, 6, 11, 12, 13, and 14 of Section 22, Legal Subdivisions 3, 6 and 7 of Section 27, all within Township 21, Range 1, West of the 6th Meridian, the location of which is shown approximately on the plan attached to the said water licences.

(b) The approximate areas of Crown Land authorized to be occupied under this permit are:

• diversion dam	0.61 hectares
• diversion channel, control structure and saddle dams (1400 feet in length and 200 feet in width)	2.59 hectares
• spillway and cut-off dam	0.73 hectares
• Walter Hardman Dam	1.62 hectares
• Cranberry Lake reservoir (headpond)	18.41 hectares
• penstock (3300 feet in length and 100 feet in width)	3.07 hectares
• Walter Hardman Powerhouse site	<u>0.61 hectares</u>
TOTAL AREA	27.64 hectares

(c) Prior to the cutting, destruction or flooding of any timber, the permittee shall apply for and obtain a licence to cut timber from the District Forest Manager. The amount of stumpage, royalty and (or) compensation payable to the Crown in respect of trees, including merchantable or young growth, cut, removed, damaged, or destroyed by the permittee, shall be the sum or sums fixed by the Forest Service of the Province of British Columbia.

(d) This permit is appurtenant to the undertaking to which the aforesaid water licences are appurtenant.

(e) This permit shall become void if the water licences with respect to which the permit is issued should terminate, be abandoned or cancelled, or amended so as to render this permit unnecessary.

(f) This permit is issued and accepted on the understanding that the permittee shall indemnify and save harmless the Government of the Province of British Columbia for all loss, damage to works, cost or expense suffered by the permittee by reason of the Crown Land or any portion thereof being submerged or damaged by erosion or otherwise affected by flooding.

- (g) The holder of this permit shall not be entitled to compensation if the Crown grants permits to other persons to occupy the land affected by this permit.
- (h) In the event of a dispute at any time with respect to the area or boundaries of the land affected by this permit, the holder shall, at his own expense, have the said land surveyed by a duly qualified surveyor.
- (i) This permit is issued in substitution of Permit # 16163.
