PERMIT AUTHORIZING THE OCCUPATION OF CROWN LAND

The holder of Final Water Licence 126727, whose licence authorizes the storage of water from Campbell River in Campbell Lake Reservoir, is hereby authorized to occupy Crown land by flooding and by constructing, maintaining and operating thereon the works authorized under the said licence.

(a) The Crown land which is authorized to be occupied under this permit for flooding are portions of:

- West 1/2 District Lot 85, Plan 1583R;
• District Lots 86, 89 & 92, Plan 1584R;
• Lot 1 of District Lot 87, Plan 27013;
• District Lots 90, 91, 94, 95, 96, 98, 99, 100, 101, 102, 110, 152; and unsurveyed land, all within Sayward District;
• Block 41;
• NE1/4, Section 31 & NW1/4 Section 32, Township 2, Plan 552A, shown on Plan 1574R, all within Comox District,

lying below the 179.80 metre contour being Campbell Lake Reservoir, the location of which is shown approximately on the attached plan. The storage of water in the reservoir will be as set out in Final Water Licence 126727 or as otherwise approved in writing by the Comptroller of Water Rights. Flooding of Crown land above the full supply level set out in Final Water Licence 126727 must be in accordance with the Operation, Maintenance and Surveillance Manual referred to in the said licence.

(b) The Crown land which is authorized to be occupied under this permit for damsite is a portion of unsurveyed land, Sayward District, the location of which is shown approximately on the attached plan.

(c) The approximate dimensions of the Crown land authorized to be occupied under this permit are:

(d) Prior to cutting, destruction or flooding of any timber, the permittee shall apply for and obtain a licence to cut timber from the District Forest Manager. The amount of stumpage, royalty and/or compensation payable to the Crown in respect of trees, including merchantable or young growth, cut, removed, damaged, or destroyed by the permittee, shall be the sum or sums fixed by the Forest Service of the Province of British Columbia.

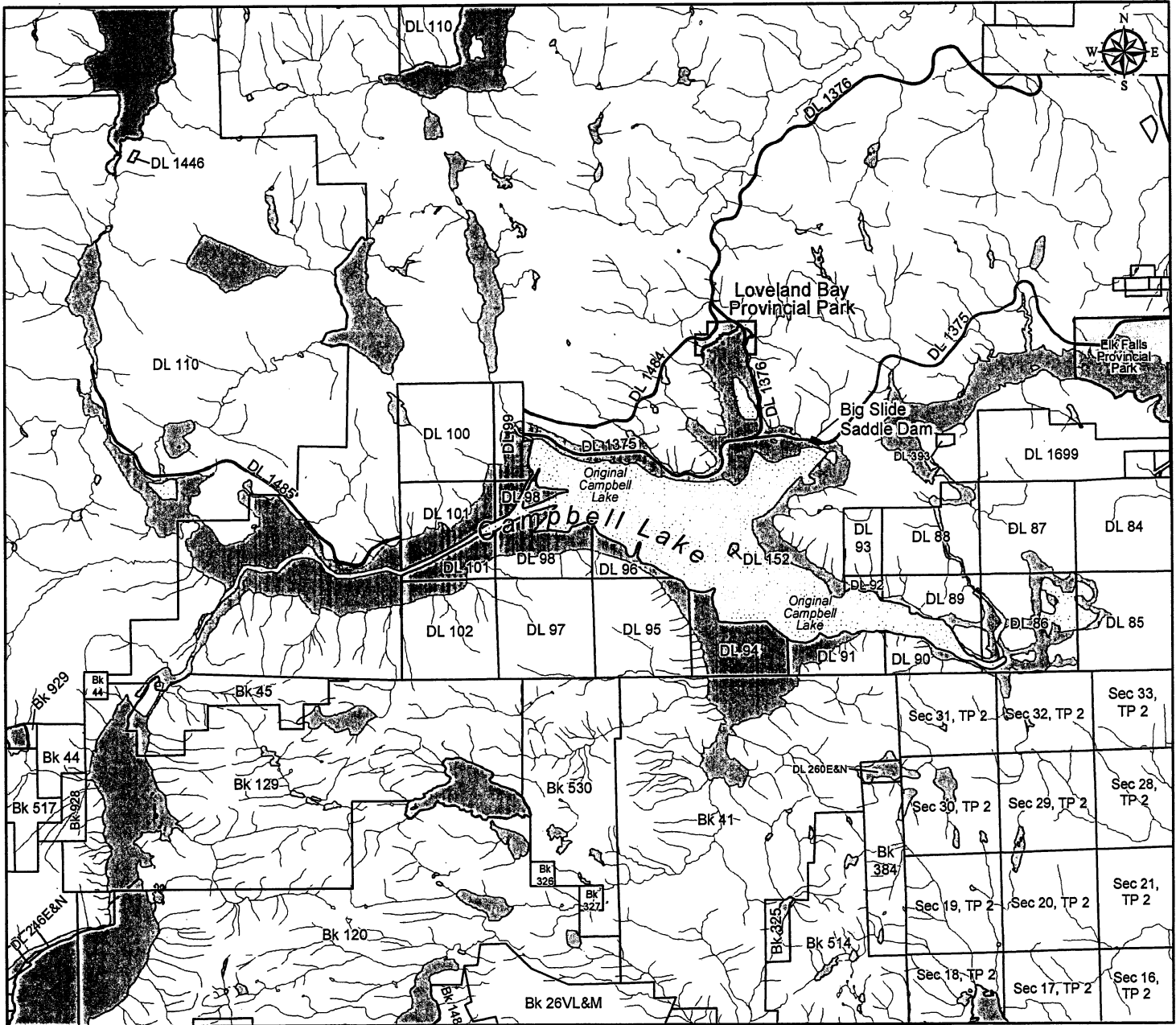

- (e) This permit is appurtenant to the land, mine, or undertaking to which the aforesaid water licence is appurtenant.
- (f) This permit shall become void if the water licence with respect to which the permit is issued should terminate, be abandoned or cancelled, or amended so as to render this permit unnecessary.
- (g) This permit is issued and accepted on the understanding that the permittee shall indemnify and save harmless the Government of the Province of British Columbia for all loss, damage to works, cost or expense suffered by the permittee by reason of the Crown land or any portion thereof being submerged or damaged by erosion or otherwise affected by flooding.
- (h) The holder of this permit shall not be entitled to compensation if the Crown grants permits to other persons to occupy the land affected by this permit.
- (i) In the event of a dispute at any time with respect to the area or boundaries of the land affected by this permit, the holder shall, at his own expense, have the said land surveyed by a duly authorized surveyor.
- (j) This permit replaces Permit No. 4063.
