On the recommendation of the undersigned, the Administrators by and with the advice and consent of the Executive Council, orders that

 The following described lands in the Vancouver Mining Division, Group 1, New Westminster Land District, are established as a mineral reserve and as a placer mining reserve:

Commencing at a point on the West bank of the Cheakamus River, said point being the Southeast corner of District Lot 3669, Group 1, New Westminster Land District; thence in a Westerly direction along the Southerly boundary of said Lot 3669 to the point of intersection with the 400 m contour of elevation; thence in a Northerly and Easterly direction along the said 400 m contour of elevation to its point of intersection with the Westerly boundary of Lot 2945, Group 1, New Westminster Land District, said lot being the British Columbia Railway: thence Northerly following the Westerly boundary of said Lot 2945 to its point of intersection with the aforementioned 400 m contour of elevation; thence in a Northerly, Easterly and Southerly direction following the 400 m contour of elevation to a point due East of the Southeast corner of District Lot 5365, Group 1, New Westminster Land District; thence in a straight line in a Southeasterly direction to a point on the Westerly boundary of the Garibaldi Provincial Park, said point being 2425 m East, more or less, and 100 m South, more or less, of the most Southerly Southeast corner of District Lot 6421, Group 1, New Westminster Land District; thence due East 1510 m; thence due South 3017 m; thence due West 1510 m, more or less, to the said Westerly boundary of Garibaldi Provincial Park; thence on a


