**Re: Cancellation of a Registration of Water Removal
under the *Water Protection Act***

I have received your annual report dated November 17, 2003 and note that there has been a change in ownership of the land to which the registration is appurtenant. The registration of Clearly Canadian Beverage Corporation ("Clearly Canadian") under Section 12 of the *Water Protection Act* is appurtenant to Lot 1, Section 20, Tp 5, ODYD, Plan 30557 and Lot 1, Section 20, TP 5, ODYD, Plan 36693.

Registration is required to permit the removal of water from British Columbia in containers over 20 litres. Aynsley International Trading Corp. has acquired from Clearly Canadian the appurtenant lands to the registration. Under Section 13 of the *Water Protection Act*, registration will pass with the disposition of these parcels of land.

Section 13 of the *Water Protection Act* states;

13 (1) The registration of an unlicensed registrant passes with the disposition of the land, mine or undertaking to which the registration is appurtenant.

(2) On the disposition to any person of the whole or any part of any land, mine or undertaking to which the registration of an unlicensed registrant is appurtenant, the comptroller must,

(a) in the case of a disposition of the whole, cancel the registration of the person making the disposition and register the other person as an unlicensed registrant instead of the person making the disposition, or

(b) in the case of a partial disposition, amend the registration of the person making the disposition to reflect the disposition and register the other person as an unlicensed registrant in respect of the part disposed of to that other person.
