



# Province of British Columbia *Water Act*

## Section 61(1) Certificate of Incorporation of the Beaton Creek Water Users' Community

File No: 3003050

This certificate incorporates the Beaton Creek Water Users' Community (the "Community").

The Community is incorporated for the purposes of constructing, operating and maintaining storage structures at the outlet of Dairy Lake (tributary to Beaton Creek), East Dairy Lake (tributary to Kwilalkwila Creek) and Beaton Lake (tributary to East Duffy Creek), in the Kamloops Water District. The Community holds Conditional Water Licence 116209 authorizing the storage of water in Dairy and East Dairy Lakes for supply to members of the Community. The Community is given all the powers set out in Section 52 of the *Water Act* in respect to storage works on Dairy, East Dairy and Beaton Lakes authorized under following licences:

The Community is also incorporated for the purposes of constructing, operating and maintaining works on Beaton Creek (located at point of diversion identified as PD51028) used to divert water into the East and West Channels of Beaton Creek, and on West Channel of Beaton Creek (located at point of diversion identified as PD51012) used to re-divert water into Beaton Lake. The Community is given all the powers set out in Section 52 of the *Water Act* in respect to diversion works at PD51028 and PD51012 authorized under the following licences:

This Certificate of Incorporation replaces the Certificate of Incorporation issued by the Deputy Comptroller of Water Rights on the 17th day of April, 1998.
