

## Water Act Section 62 (1) Recall and Re-issue of the Certificate of Incorporation of the Bonaparte Dam Water Users' Community

File No. 3000588

The Certificate of Incorporation of the Bonaparte Dam Water Users' Community issued by the Deputy Comptroller of Water Rights on the 25th day of July, 1991, is hereby recalled and the following issued in lieu thereof:

Whereas the holders of water licences share a common interest in a licence to store water from Bonaparte River (the reservoir being Bonaparte Lake), and hold water licences authorizing the diversion and use of water from Bonaparte River for irrigation purpose, I hereby incorporate those licences into a water users' community as follows:

- 1) The name of the Water Users' Community shall be Bonaparte Dam.
- 2) The Water Users' Community is incorporated for the purposes of construction, operation and maintenance of the Bonaparte Dam at the outlet of Bonaparte Lake, and in respect of the following storage licence, is given all the powers set out in Section 53 of the Water Act:

The respective interests of the members of the Water Users' Community, as provided under Section 55 of the Water Act, shall be determined from the following licences authorizing the diversion and use of water from Bonaparte River for irrigation purpose; where such use is supported by storage from the aforementioned licence:
