Recall and Re-issue of the Certificate of Incorporation

of the

Dog Creek Water Users' Community

File: 4002625

The Certificate of Incorporation for the Dog Creek Water Users' Community, issued by the Deputy Comptroller of Water Rights on the 20th day of August, 1993, is hereby recalled and the following issued in lieu thereof:

Whereas certain holders of water licences share a common interest in the diversion and use of water from Dog Creek, I hereby incorporate those licences into a Water Users' Community as follows:

- 1. The name of the Water Users' Community shall be Dog Creek.
- 2. The Water Users' Community is incorporated for the purpose of maintaining and operating a water system from Dog Creek, and in this respect is given all the powers set out in Section 53 of the *Water Act*.
- 3. The following licences, or any licences issued in substitution thereof, are included within the membership of the Water Users' Community:
