Recall and Re-Issue of the Certificate of Incorporation
of the
Durand Creek Water Users' Community

The Certificate of Incorporation of the Durand Creek Water Users' Community, issued by the Deputy Comptroller of Water Rights on the 13th day of April, 1976, is hereby recalled and the following issued in lieu thereof:

WHEREAS the holders of certain water licences share a common interest in the diversion of water from Guichon & Chartrand Creeks into storage at Tunkwa and Leighton Lakes, and water licences which authorize the downstream rediversion and use of water from Durand and Tunkwa Creeks, I hereby incorporate those licences into a water users' community as follows:

- 1) The name of the Water Users' Community shall be Durand Creek.
- 2) The Water Users' Community is incorporated for the purposes of operating and maintaining diversion structures and ditches from Guichon and Chartrand Creeks and storage structures at the outlets of Tunkwa and Leighton Lakes, and in respect to the following storage licences is given all the powers set out in Section 52 of the *Water Act*:


