Recall and Re-Issue of the Certificate of Incorporation of the  
Eagle Creek Water Users' Community

The Certificate of Incorporation of the Eagle Creek Water Users' Community issued by the Deputy Comptroller of Water Rights on the 9th day of December, 1981, and any amendments thereto, are hereby recalled and the following issued in lieu thereof:

Whereas the holders of certain water licences on Eagle Creek share a common interest in the diversion of water, I hereby incorporate those licences into a water users' community as follows:

1. The name of the Water Users' Community shall be Eagle Creek.
2. The Water Users' Community is incorporated for the purpose of maintaining and operating a water system to supply water for domestic and irrigation purposes to lands appurtenant to licences included within the membership.
3. The following licences, or any licences issued in substitution thereof, are included within the membership of the Water Users' Community:


