Recall & Re-Issue of the Certificate of Incorporation of the Fife Water Users' Community

The Certificate of Incorporation of the Fife Water Users' Community issued by the Deputy Comptroller of Water Rights on the 19th day of April, 1983, and any amendments thereto, are hereby recalled and the following issued in lieu thereof:

Whereas the holders of water licences share a common interest in the diversion and use of water from the South Outlet Sutherland Creek, I hereby incorporate those licences into a water users' community as follows:

- 1. The name of the Water Users' Community shall be Fife.
- 2. The Water Users' Community is incorporated for the purposes of maintaining and operating works from the South Outlet Sutherland Creek and in this respect is given all the powers set out in Section 53 of the Water Act.
- 3. The following licences, or any licences issued in substitution thereof, are included within the membership of the Water Users' Community:
