

## Water Act Section 62 (1)

## Recall and Re-issue of the Certificate of Incorporation of the Florence Lake Water Users' Community

File No: 1001215

The Certificate of Incorporation of the Florence Lake Water Users' Community issued by the Deputy Comptroller of Water Rights on the 11th day of January, 1993, and any amendments thereto, are hereby recalled and the following issued in lieu thereof:

Whereas the holders of water licences share a common interest in the storage of water from Priest Creek (the reservoir being Florence Lake), and divert and use water from Florence Lake for domestic and irrigation purposes. I hereby incorporate those licences into a water users' community as follows:

- 1) The name of the Water Users' Community shall be Florence Lake.
- 2) The Water Users' Community is incorporated for the purposes of construction, operation and maintenance of the Florence Lake Dam on Priest Creek, and in respect to the following storage and conservation licences, is given all the powers set out in Section 53 of the Water Act:
