This Certificate of Incorporation replaces the Certificate of Incorporation for the Gibson-MacNeal Water Users' Community issued by the Deputy Comptroller of Water Rights on May 16, 1955.

All assets, rights, claims and financial obligations of the Gibson-MacNeal Water User's Community shall become assets, rights, claims and financial obligations of the Community.
