HAVING RECEIVED petitions to establish a water users' community from the holders of water licences who share a common interest in the diversion and use of water from Kirby Lake, in accordance with my notice dated December 14, 1995, I hereby incorporate a water users' community as follows:

- 1. The name of the Water Users' Community shall be Kirby Lake.
- 2. The Water Users' Community is incorporated for the purposes of maintaining and operating a water system from Kirby Lake, and in this respect, is given all the powers set out in Section 53 of the *Water Act*.
- 3. The following licences, or any licences issued in substitution thereof, are included within the membership of the Water Users' Community:
