Recall and Re-Issue of the Certificate of Incorporation
of the
Mallandaine Water Users' Community

The Certificate of Incorporation of the Mallandaine Water Users' Community, issued by the Deputy Comptroller of Water Rights on the 9th day of February, 1976, and any amendments thereto, is hereby recalled and the following issued in lieu thereof:

WHEREAS the holders of certain water licences share a common interest in the diversion and use of water from Mallandaine, Compton, Empire & Keirn Springs, I hereby incorporate those licences into a water users' community as follows:


- 1) The name of the Water Users' Community shall be Mallandaine.
- 2) The Water Users' Community is incorporated for the purpose of operating and maintaining a water system from Mallandaine, Empire, Compton & Keirn Springs, and in this respect is given all the powers set out in Section 52 of the *Water Act*.
- 3) The following licences, or any licences issued in substitution thereof, are included within the membership of the Water Users' Community:
