**Recall and Re-Issue of the Certificate of Incorporation**  
**of the**  
**McKinney Road Water Users' Community**

The Certificate of Incorporation of the McKinney Road Water Users' Community, issued by the Deputy Comptroller of Water Rights on the 27th day of February, 1981, and any amendments thereto, are hereby recalled and the following issued in lieu thereof:

WHEREAS the holders of certain water licences share a common interest in the diversion of water from Baldy Creek, West Fork of Baldy Creek, McCuddy Creek and Arminius Springs for irrigation use, and storage of water in McCuddy Reservoir Nos. 1 & 2, Baldy Reservoir No. 1, Cross Pond and three unnamed ponds to support irrigation use, I hereby incorporate those licences into a water users' community as follows:

- 1) The name of the Water Users' Community shall be McKinney Road.
- 2) The Water Users' Community is incorporated for the purposes of operating and maintaining diversion and storage structures for irrigation supply and in respect to the following licences is given all the powers set out in Section 52 of the *Water Act*:

- 4) Each members' rights granted herein are transferable to the successors-in-title of the parcels of land appurtenant to the licences included within the membership.
