The Certificate of Incorporation of the Meighan Creek Water Users' Community, issued by the Deputy Comptroller of Water Rights on the 22<sup>nd</sup> of March 2009, is hereby recalled and the following issued in lieu thereof:

WHEREAS the holders of the water licences share a common interest in the diversion and use of water from Meighan Creek, I hereby incorporate those licences into a water users' community as follows:

1. The name of the Water Users' Community shall be Meighan Creek.
2. The Water Users' Community is incorporated for the purpose of operating and maintaining a water system for domestic supply from Meighan Creek, and in this respect is given all the powers set out in Section 52 of the *Water Users' Community Act*.
3. The following licences, or any licences issued in substitution thereof, are include within the membership of the Meighan Creek Water Users' Community.
