Recall and Re-Issue of the Certificate of Incorporation
of the
Monte Lake Water Users' Community

The Certificate of Incorporation of the Monte Lake Water Users' Community, issued by the Comptroller of Water Rights on the 8th day of June, 1965, is hereby recalled and the following issued in lieu thereof:

WHEREAS the holders of certain water licences share a common interest in the diversion of water from Monte & Pringle Creeks for irrigation and domestic use, and storage of water in Monte Lake to support irrigation use, I hereby incorporate those licences into a water users' community as follows:

- 1) The name of the Water Users' Community shall be Monte Creek.
- 2) The Water Users' Community is incorporated for the purpose of operating and maintaining diversion and storage works on Monte and Pringle Creeks and Monte Lake, and in respect to the following licences, or any licences issued in substitution thereof, is given all the powers set out in Section 52 of the *Water Act*:


